The District will change a student's name and gender on official records when the name of the student is changed by the appropriate court action.</p>					
q11	Special Education Considerations for Gender Diverse Students with Disabilities: Specifying that gender identity and gender expression are not defined as a disability category under the Individuals with Disabilities Education Act (IDEA) or Section 504 of the Rehabilitation Act (Section 504).	74.55%	70.04%	41.48%	81.12%	16.67%
q12	Athletics and School Activities: CCSD complies with Nevada Interscholastic Activities Association Regulations related to gender diverse students. Students cannot be required to provide medical or other documentation that is not required of all students to participate, according to 2016 Title IX guidance. q14	<p>Professional Development: Senate Bill 225 (2017) requires that CCSD personnel undergo training concerning the needs of persons with diverse gender identities or expressions.
