The Excellence in Education Hall of Fame is a long-running tradition of the Clark County School District, established in 1987 by the Board of Trustees.

The Hall of Fame recognizes *extraordinary and lasting* contributions to education in the Clark County School District. Each year the recipients' names are added to the Excellence in Education display in the foyer of the Edward A. Greer Education Center.

**Nomination Deadline: April 27, 2018**

Nominations may be made in one of the following categories:

- ◆ Clark County School District Employees
- ◆ Programs, departments, schools, or events
- ◆ Citizens, community agencies, or parent groups

## Selection Criteria and Process

### CRITERIA

- ◆ Extraordinary and lasting contributions to education in Clark County School District.
- ◆ Proven significant impact on the improvement of student achievement.
- ◆ Unique and/or innovative approach to education.
- ◆ Significant number of individuals impacted by the nominee.
- ◆ Substantial contribution that is ABOVE and BEYOND one's normal responsibilities or what is generally expected of the individual or program.
- ◆ Involvement in education and related issues outside one's own area.
- ◆ Demonstrated collaboration with parents, community, and/or other educators.
- ◆ Documented minimum three-year track record of program or individual accomplishment.

### SELECTION

Nominations are reviewed through a blind process and up to 10 recipients will be selected for recognition. The recipients will be invited to be recognized at the CCSD Board Meeting on May 17, 2018.
