ADVERTISEMENT FOR BIDS

Pursuant NRS 338.1385, bids will be received at the Clark County School Contract, Procurement and Compliance, 1180 Military Tribute Place, Henderson, NV 89074 until **1:30 p.m., July 26, 2018**, and then opened and read aloud publicly for the furnishing of all labor and materials to perform the Work in conjunction with the construction of:

Robert O. Gibson Middle School Replace HVAC Components MPID 0013662, PWP# CL-2018-144

The main campus buildings have existing unit-ventilator air handlers that are two-pipe manual changeover between heating and cooling operations that will be removed entirely along with the corresponding chiller(s), cooling tower(s), and boiler(s) systems. The replacement design will have rooftop water source heat pump units, and single-zone vertical water source heat pump units on structural frames with exposed duct above the roof. The new water source system shall have new piping installed throughout the facility. The dean's/office building has packaged rooftop gas/dx unit and will be replaced with current code compliant direct replacement packaged rooftop unit. The existing building control system shall be removed and replaced with a new direct digital control (DDC) system that will also include the remote dean's/office building. New cooling tower location and electrical upgrades will be required for the new water source system. Contractor shall include phasing plan for the work during school hours and occupied dates. The schools exiting HVAC must stay operational during school hours.

Prequalified Bidders shall have a Nevada Contractor's License with the Classification of C1 or C21.
