Replace Clock/Intercom/PA System. All cable shall be replaced with indoor/outdoor cable that will be installed on J-hooks above accessible ceilings. New conduit will be installed between buildings to allow for cable routing. A new clock/intercom head end will be installed in the existing head end room. All field devices will be replaced and new equipment will be added to ensure proper coverage for the school. The conduit in the new addition will be re-used along with the existing underground to that building.
