The Work consists of Prepping and Repainting the exterior of the building. Prep consists of power wash, wet sand as needed, spot prime areas needed and repaint all metals with Pro Industrial High Performance Acrylic. Bid includes power wash all areas to be painted, mesh screens, all tube railing, small and large. Full wrap on all doors including masking all letters or signs, exterior side of all roll up doors, stairwells, including railing, underside and top of hallway metal canopies and awnings, (+/-) 5000 Linear ft. of metal cap flashing around complex. Stucco repairs as needed, paint all exposed stucco, underside and topside of hallway, walkways, and pitched ceilings and roofs at entries and by Cafeteria. All ext. window mullions, lockers downstairs and upstairs along walls (excluding any open area lockers). All light sconces attached to building.
