## Overview

Education Services, a division of the Clark County School District (CCSD), oversees non-traditional schools and programs throughout Clark County. The Education Services Division provides instruction and related services to over 50,000 students annually. The schools and programs serve the most at-risk students offering instruction to those students who desire, or have been identified, to receive a non-traditional education. The unique needs of these students require a proactive, progressive approach in delivering curriculum and instructional programs.

There are five geographically zoned behavior schools which serve as short-term intervention programs (usually 4-9 weeks) for secondary students (grades 6-12) who have committed disciplinary infractions at comprehensive schools. Prior to any change of placement for a student with disabilities, the student's parent/guardian must be provided notice of the student's misbehavior and a copy of the "Procedural Safeguards Rights Pamphlet". An Individualized Education Program (IEP) or Section 504 Accommodation Plan meeting must be convened to conduct an evaluation of the student's current educational records and to review the relationship between the student's disability and the misbehavior, called a "manifestation determination review". Individualized Education Program (IEP) and Section 504 Accommodation Plans will be implemented at the behavior school. Additional information regarding this process may be provided by the comprehensive school's Special Education Instructional Facilitator (SEIF) and is also contained in the "Procedural Safeguard Rights Pamphlet".

Students who attend behavior schools are usually expected to return to a comprehensive school upon completion of the program. The behavior school program provides required academic courses for students allowing them to continue with their educational progress in a structured environment with emphasis on assisting the student in improving self-control, social interaction and instilling life-skills. The schools are spread geographically throughout the Las Vegas valley. Students generally attend the school location closest to their residence and CCSD transportation may be provided. Most students complete their program and return to a comprehensive school with improved attendance and acquired coping skills.

Students are required to attend school regularly, follow all school rules and regulations, adopt and maintain a positive attitude and comply with the dress code policy.

Additional information about the school a student is assigned to attend will be provided at the time of registration/orientation. For any questions, please contact the school principal.
