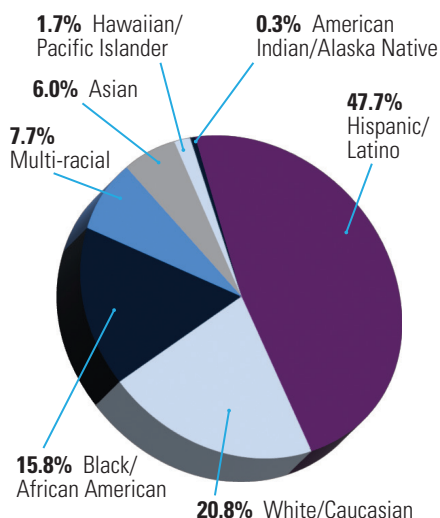

Key Takeaways From ESSER III Funding (Projected and/or Spent)

\$603 Million for 11 Student Success projects, including \$204 million to upgrade technology, \$93 million for Tier I instructional materials for science, \$74 million for summer learning programs, \$48 million for supplemental instructional materials for social-emotional learning, and \$27 million for mental health services

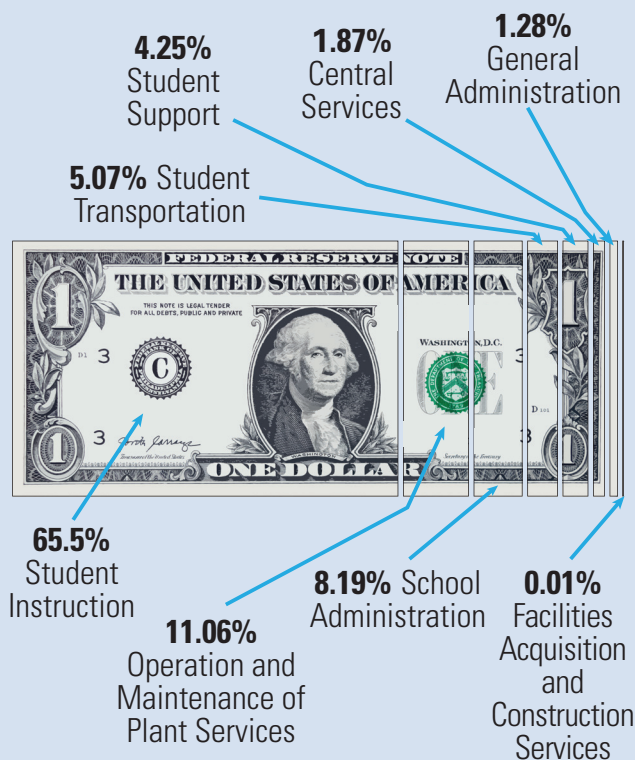
\$94+ Million for 7 Teachers, Principals, and Staff projects, including nearly \$70 million in bonuses to retain and recruit top teachers – helping to drastically reduce the number of classroom vacancies – and almost \$12 million for literacy professional learning

\$56+ Million for COVID-19 Mitigation, Continued Response and Other Costs, including \$46 million for Health Services to provide a significant investment in testing, staffing of nurses, and providing personal protective equipment to enable a safe return to school
