Immunization Requirements

For the most current information about the appropriate spacing and minimum age requirement of the various vaccine dosages, please review the 2022-2023 School Year Immunization guidelines listed at http://www.ccsd.net/parents/enrollment/.

- <u>Diphtheria, Tetanus, Pertussis (DTP)</u>: Minimum of 4 doses. The final dose must be on or after the fourth birthday, or a fifth dose is required.
- Polio: Minimum of 3 doses. Final dose must be on or after the fourth birthday, or a fourth dose is required.
- <u>Measles, Mumps, Rubella (MMR)</u>: Two doses: first dose must be on or after the first birthday. First and second doses must be separated by at least four weeks.
- <u>Varicella/Chicken Pox</u>: Two doses required. First dose must be on or after first birthday. First and second doses must be separated by at least 4 weeks if age 13 years of age or older. Minimum interval of three months between first and second doses if less than 13 years. Physician verification of past disease required for exemption.
- Hepatitis A: Two doses. The second dose must be given at least six months after the first dose
- <u>Hepatitis B</u>: Three doses. Must have a minimum of 16 weeks between first and third dose. Child must have been over 24 weeks old when the third dose was given.
- <u>Tdap</u>: One dose. Required of all students grade 8th 12th.
- MCV4: One dose. Required of all students grade $8^{th} 12^{th}$. The minimum age is 10 years.

Grade Level Placement and Enrollment Limitations

In accordance with State and District policies, foreign exchange students are assigned to a grade level based on their date of birth.

- Grade 9 The student will be 14 years old by September 30 of the year of enrollment.
- Grade 10 The student will be 15 years old by September 30 of the year of enrollment.
- Grade 11 The student will be 16 years old by September 30 of the year of enrollment.
- Grade 12 The student will be 17 years old by September 30 of the year of enrollment.

Students who have graduated from high school in their home country will not be accepted as foreign exchange students in the District. Additionally, students assigned to the twelfth grade will only be accepted for full year placements when enrolling in August. Students will not be accepted for enrollment in the twelfth grade for a full year for enrollment in January.

Grade and Citizenship Policy

Foreign exchange students are required to make adequate academic progress in all classes. If a student's grades fall below a C, the student will be placed on probation. This requires the organization to provide tutoring services for the student. If the student continues to earn grades below the minimum GPA required, the organization will be required to withdraw the student from CCSD.

Students are expected to demonstrate appropriate behavior and citizenship in all classes as well as excellent attendance. If a student's citizenship grades and attendance "Needs Improvement" or is "Unsatisfactory", the student will be placed on probation. If the student continues to earn low citizenship grades or exhibit poor attendance patterns, the sponsoring organization will be required to withdrawn the student from CCSD.
