



Ski and Snowboard Consent, Waiver and Release Agreement

This form requires the signature of the Student (regardless of age) and Parent/Guardian (if the applicant is a minor).

I _____ (Parent/Guardian and _____ (Student) understand and agree that Student will be participating in an extracurricular ski and snowboarding program (the Program). Participation in the Program is not required, and is completely voluntary.

Parent/Guardian and Student agree to the following and hereby provide consent for Student to participate in the Program, subject to the following terms and conditions:

ASSUMPTION OF RISK: PARENT/GUARDIAN AND STUDENT UNDERSTAND AND ACCEPT THAT STUDENT’S PARTICIPATION IN THE PROGRAM MAY SUBJECT STUDENT TO NUMEROUS INHERENT RISKS OF INJURY OR DEATH, INCLUDING, WITHOUT LIMITATION; THE NATURAL ENVIRONMENT; COLLISIONS WITH NATURAL OR MANMADE STATIONARY OBJECTS; COLLISIONS WITH OTHER SKIERS/SNOWBOARDERS; FALLS; LOSS OF CONTROL; NEGLIGENCE OR INTENTIONAL ACTIONS OF STUDENT AND/OR OTHERS; DANGEROUS NATURAL AND MANMADE CONDITIONS (INCLUDING, WITHOUT LIMITATION, ICE, SNOW, BARE SPOTS, NATURAL AND ARTIFICIAL TERRAIN FEATURES, TREES, LOGS, BRANCHES, ROOTS, ROCKS, GRAVEL, WATER, MOGULS, AND VARIATIONS IN AND/OR MODIFICATIONS TO SURFACE AND/OR TERRAIN CONDITIONS); EQUIPMENT FAILURE; COLD OR FREEZING TEMPERATURES; DEHYDRATION; SUNBURN; BEING STRUCK BY SKIS, SNOWBOARDS, OR OTHER EQUIPMENT; SLIPPERY OR UNEVEN STEPS, WALKWAYS, PARKING LOTS, AND OTHER NATURAL OR MANMADE OUTDOOR SURFACES; WILDLIFE; HIGH ALTITUDE; MARKED AND UNMARKED OBSTRUCTIONS; SKI LIFTS; AND OTHER HAZARDS.

IN SPITE OF THE FOREGOING, PARENT/GUARDIAN AND STUDENT ASSUME ALL RISK OF INJURY OR LOSS OF LIFE TO STUDENT AND LOSS OF OR DAMAGE TO PROPERTY (INCLUDING THEFT) ARISING OUT OF STUDENT’S PARTICIPATION IN THE PROGRAM.

WAIVER AND RELEASE: In consideration of being allowed to participate in the Program, Parent/Guardian and Student specifically release and forever discharge the Clark County School District (District), its Board of School Trustees, employees, agents, administrators, teachers, counselors, advisors, and volunteers from all liability or claims for injury, illness, death, or loss of or damage to property which Student may suffer while participating in the Program. This discharge specifically includes, but is not limited to, liability or claims for injury, illness, death, or loss of or damage to property caused by the negligence of the District, its Board of School Trustees, employees, agents, teachers, counselors, advisors, and volunteers. Parent/Guardian and Student hereby agree to release the District, its Board of School Trustees, employees, agents, teachers, counselors, advisors, and volunteers and hold them harmless from all liability for any injury, illness, death, or loss of or damage to property, whether caused by the negligence of the District, its Board of School Trustees, employees, agents, teachers, counselors, advisors, and volunteers, or whether based upon breach of contract, breach of warranty, or any other legal theory. In signing this document, Parent/Guardian and Student fully recognize that if injury, illness, death, or loss of or damage to property occurs to Student while participating in the Program, Parent/Guardian and Student will not have any right to make a claim or file a lawsuit against the District, its Board of School Trustees, employees, agents, teachers, counselors, advisors, and volunteers for any claim or cause of action arising from any injury, illness, death, or loss of or damage to property arising in any way from Student’s participation in the Program.
