Mission Statement

Our mission at Silverado High School is to provide all students equal opportunities to become responsible individuals able to adapt effectively and to contribute productively in an ever-changing world, and to ensure all students, parents, faculty, and staff are provided the resources necessary to achieve this goal.

Principal's Highlights

Silverado is proud of its students, staff, and parents who have worked together to establish a rich tradition of excellence as we prepare our students for the challenges of the 21st century.

- Our annual "Empty Bowls" event raised over \$8000 for food banks in our community.
- Four students were National Merit Scholarship Finalists; two students qualified for the National AP Scholar Award.
- The yearbook received the "Best of Show" award at the Journalism Education Association convention.
- 78% of our seniors sent transcripts to 2- or 4-year institutions, with almost \$6,000,000 awarded in scholarships.
- Our STEP-UP program had students taking courses that earned them college credit while preparing for a career as teachers.
- The Food Production students were state runners-up in the Nevada ProStart state competition.
- Our Global Lab program links biology students with others around the world to discuss/research common environmental issues.
- Student Council received the prestigious Silver Star award from National Association of Student Council.
- Concert Choir, Chamber Choir, Wind Ensemble and Advance Orchestra received superior ratings at CCSD music festivals.

Goals and Objectives

Goal 1

The number of non-proficient Special Education students in mathematics will be reduced by 10%.

Objective(s):

Last year only 30% of the Special Education subgroup were proficient in mathematics, 22.3% lower than the AYP target. The Special Education subgroup will meet the 52.30% target percent proficient score or show a 10% reduction in the number of non-proficient students.

Goal 2

The number of non-proficient Special Education students in English-Language Arts (ELA) will be reduced by 10%.

Objective(s):

Last year 57.86% of Special Education students were proficient in ELA, 20.4% below the AYP target. The Special Education subgroup will meet the 77.90% target proficient score or show a 10% reduction in the number of non-proficient students.

Goal 3

Silverado High School will test at least 95% of the students in each of its AYP subgroups.

Objective(s):

Three subgroups, Special Educations students, Black/African American students, and students enrolled in the federal Free and Reduced Lunch Program, fell short of the 95% participation goal. These three groups will be the focus of a new attendance incentive/tracking initiative to reach 95%.

Demographics and Student Information

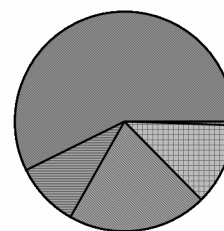

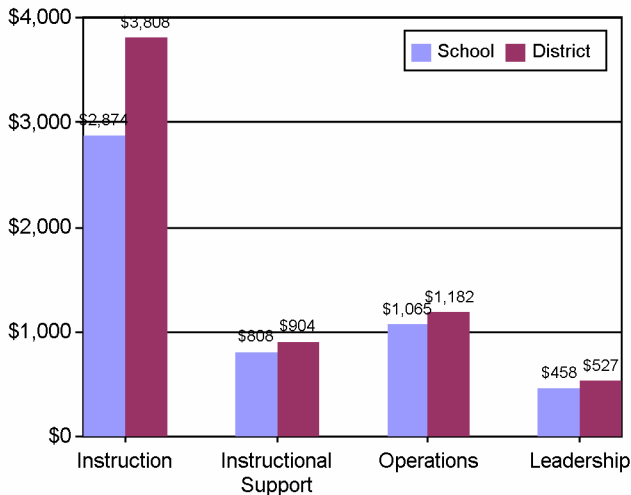

Parent/Community Involvement

Silverado High School provides two-way, meaningful communication with parents, family, and its community on a regular basis through a variety of resources. Our on-going, daily communication is focused through our school webpage/Edline home page. Through this homepage, all stakeholders have access to a variety of information regarding school activities, calendars, and community/state resources and links, as well as minutes from the school's Open Parent Meetings. Parents have additional access to grades, attendance, and email links to teachers. In addition, through our link between SASI and Edline, the school regularly sends out important reminders and information to parents by e-mail.
