**CLARK COUNTY SCHOOL DISTRICT**

A Board affiliated committee is composed of non-Board members and includes one or more Board members participating.

1. The President shall make the following appointments as voting members or liaisons, including:
  - A. CCSD Boards/committees
  - B. Boards/committees created by statute
  - C. National or State School Board affiliates
  - D. National or Local Boards/committees on which the Board traditionally participates
2. Appointments to Board Affiliated or Community Committees must be made according to the bylaws of the committee. The bylaws and/or any changes to the bylaws of such committees must be approved by the Board.
3. If the committee is advisory to the Board, the Board is responsible for providing ongoing training in governance issues. Also, individual Board members assigned to committees should report to the full board on a regular basis. Board liaisons should not speak to issues that have not been officially decided by the Board. Recommendations or proposals from advisory committees must be processed as outlined in GP-10: Construction of the Agenda.
