No person may sign up for another individual. No person may yield his or her time to another person. A person wishing to speak on agenda items and non-agenda items will be allowed 2 minutes to address the Committee. If the amount of public comment is large, the time may be adjusted to accommodate more speakers.

The Committee will no longer be summarizing written comments at the work sessions and regular meetings, but the comments will be included on the record of the agenda.
