INFORMATIONAL REPORTS

Rick Baldwin reported that the Legislature had approved the Bond Roll Over Bill and Governor Brian Sandoval had signed it. He explained what that meant for the Clark County School District. Staff had provided a map of proposed new schools which is a two year plan. Twelve new schools and two replacement schools were included in the map. He reviewed possible new schools and informed AZAC that more information would be provided in the Fall.

Brian Krall asked if there would be any new school sites for middle and high school.

Mr. Baldwin stated at the time of developing sites staff was asked to site elementary schools; however, others will be worked on in the future.

Becky Nielson stated she was excited for the replacement of Rex Bell Elementary School.

Rick Baldwin informed AZAC that some projects will be phasing construction projects, because the schools will still have to operate during the replacement.

Trustee Tew expressed her excitement for the possibility of siting new schools.

APPROVED ZONING FOR THE 2015-2016 SCHOOL YEAR

Rick Baldwin reported all zoning recommendations for the 2015-2016 school year were approved by the Board of School Trustees on February 26, 2015.

THE 2015-2016 ZONING SEASON

Rick Baldwin stated there is so much planning to be done with the new Bond Roll Over projects. Sheila Tarr Elementary School will be implementing a magnet program for the 2016-2017. AZAC will need to review the boundary next zoning season as well as evaluating available seating capacity throughout the district.
