Trustee Alderman referred to numbers 12 and 13 and said she expressed a concern at the previous Board meeting about using language in the policy that may not be commonly known. She said she and Trustee Cranor had discussed adding a reference to the document to tie the accounting terms to so that it is understood that the language in policy is taken from Generally Accepted Accounting Principles (GAAP).

Trustee Cranor commented that the terms "significant" and "material" are terms that are typically used in an audit, and they have a particular meaning in that context.

Mr. Weiler explained that the terms "significant" and "material" as used in a financial audit are defined by the external auditor. Regarding number 12, he offered the following language change, "...a system of internal controls that aren't consistent with Generally Accepted Accounting Principles."

Trustee Cole expressed hesitancy with referring to GAAP in the policy, stating it is interpretive in many ways. He offered the language change for number 12, "...as defined by the most recent interpretation of the District's external auditors."

Regarding number 11, Mr. Weiler suggested the language, "Invest the District's assets in a manner consistent with District Regulation 3214 and NRS Chapter 355."

Trustee Cole suggested changing the wording to be consistent with the lead in paragraph, "...he or she will not...," but agreed with Mr. Weiler's suggestion.

Trustee Cranor offered the language for number 11, "Fail to invest the District's assets in accordance with NRS Chapter 355 and District Regulation 3214." Regarding number 12, she suggested inserting the language "...in accordance with Generally Accepted Accounting Principles...," after the word "controls."

APPROVE BOARD REVIEW OF THE CLARK COUNTY SCHOOL DISTRICT BOARD OF TRUSTEES' GOVERNANCE POLICY EL-5: FINANCIAL PLANNING/BUDGETING

Approval regarding suggestions for modifications, additions, language changes, and deletions to EL-5: Financial Planning/Budgeting, as requested in Reference 5.02. By direction of the Board, any changes recommended at this meeting will not be implemented unless adopted by the public policy review process at a regular meeting of the Board of School Trustees.

Trustee Cranor said the Audit Advisory Committee would like a final review of this policy after the Board's discussion and would be preparing this language to come back to the Board for Notice of Intent at the committee's February meeting.

APPROVE BOARD REVIEW OF THE CLARK COUNTY SCHOOL DISTRICT BOARD OF TRUSTEES' GOVERNANCE POLICY EL-5: FINANCIAL PLANNING/BUDGETING (continued)

Trustee Alderman questioned number 3 and suggested inserting the word "resources" after "Provide less." She suggested adding an item C to number 6 that would reference state law.

Trustee Edwards suggested changing the word "complement" in number 6, item A, to "supplement."

Carlos McDade, General Counsel, Office of the General Counsel, offered that compliance with the statute is presumed therefore, adding the language in policy as suggested by Trustee Alderman is not necessary.

Trustee Cranor said she would take the following suggestions back to the Audit Advisory Committee for discussion: changing the language in number 3 to, "Provide fewer resources for Board...," and replacing the word "complement" with "supplement" in number 6.

Trustee Alderman suggested changing number 3 for consistency to, "Fail to provide..."

Staci Vesneske, Chief Human Resources Officer, Human Resources Division, summarized the key changes being proposed for the regulations in Items 6.01, 6.02, and 6.03.

Public Hearing

Stephen Augspurger spoke on Regulations 4111, 4111.1, and 4112, stating that many of the proposed changes need to be made, but that there needs to be a process in place that is fair, transparent and which ensures that the very best candidate is placed in every administrative position.

Trustee Edwards asked whether staff may want to look at the points raised by Mr. Augspurger.

Trustee Wright commented that she would like to see some further clarification.

Trustee Cranor said she would like to have addressed whether a break in the scoring could be published, whether it could be provided in the process so that applicants have that knowledge, and if there is a way to define the generally accepted business practices or best practices to which staff is referring in the justification for the proposed changes.

Trustee Cole suggested that perhaps the break point becomes the average of the scores of all the candidates.

Pedro Martinez, Deputy Superintendent, Instruction Unit, suggested the policies should be broad but acknowledged the Trustees' concerns regarding the process itself. He said staff would take the comments into consideration and possibly come back to the Board with a policy and procedure and would also share that information with Mr. Augspurger.

Trustee Young said these items will come back before the Board for further discussion after staff has reviewed the information and has made any necessary changes.

Andrew Slocum, Richard Tellier, Carolyn Myers, Erik Smith, Vikki Courtney, Peg Bean, Steve Peterson, Adam Berger, Rob Benson, Paul Amann, Angie Sullivan, Greta Johnson; and students Richard Ramirez, Madison Flick, and Emily Huber

The above-named speakers spoke about the impact of teachers on students and the critical need to support educators. They also spoke against the amount of testing mandated for students and the negative effect the testing is having on the school's climate.

Ruby Caliendo offered a solution to the current budget crisis, which was to have parents pay for the credit retrieval programs that are currently being offered for free.

She said she will be bringing forward recommendations for appointments to Nevada Interscholastic Activities Association (NIAA) Board of Control positions that will be coming to the end of their term.

Trustee Alderman inquired about having a Board discussion regarding the public comment portion of the meeting.

Trustee Young offered to research what needs to be done to move forward with that discussion.

Trustee Cole requested an update of the current status of the technology component of the District.

Trustee Wright requested an update on anti-bullying efforts in the District.

Trustee Alderman announced that Attendance Zone Advisory Commission (AZAC) recommendations will be coming to the Board at the February 28, 2012, special Board meeting.

Trustee Cranor announced that her upcoming Parent Advisory Committee (PAC) meeting will be focused on digital learning.

Trustee Garvey reported on the February 19, 2012, Bond Oversight Committee (BOC) meeting and said the committee is continuing to discuss Revision 17. She said a committee member has been suggesting that the Board should pursue a Nevada Revised Statute (NRS) that would require that developers fund their own development.

Trustee Garvey said after some discussion, the committee's consensus was that there needs to be further discussion and vetting of that notion before any recommendations are proposed to the Board.

Trustee Wright shared that at her upcoming PAC meeting, the topic of discussion will be math, including the Common Core Standards and where to find assistance for math.

Trustee Edwards announced that the Nevada Department of Education has received five recommendations for the position of Superintendent of Public Instruction. She shared that those finalists are Rene Cantu, James W. Guthrie, Magdelena Martinez, Caroline McIntosh, and Sylvia L. McMullen. She said the Nevada Department of Education will narrow those recommendations down to three candidates and forward those names to the Governor who will then make the selection.
