POSSIBLE CHANGES TO POLICY 7223

Trustee Edwards spoke on possible changes to the current school naming policy. The following ideas were suggested:

- The Superintendent of Schools will appoint one member of the School Name Committee. The Board of Trustees will appoint the remainder of the members of the School Name Committee.
- The name of a school or portion of a facility will not have to be rescinded before another name is approved by the School Name Committee. An application may be submitted with the understanding that the old name will be rescinded upon approval of a new school name. Rescinding of a school name would be approved by School Board of Trustees after coming before the School Name Committee. Something egregious must happen to rescind a name, such as a felony conviction. The School Name Committee will vote to rescind a name and then the School Board of Trustees would approve the rescinding.
- All former Clark County School District employees must no longer be employed by the Clark County School District for two years before they can be considered for school naming.
- Elementary schools may be named for educators, prominent citizens, etc.
- Require approval of current principal of facility for recommending a part of a school for naming.
- Person to be named should have some connection to the school.

POSSIBLE CHANGES TO SCHOOL NAME APPLICATION

Trustee Edwards asked that staff make changes to the current school name application to ensure the application reflects changes in the policy.
