Did you know that the CCSD Board of Trustees recently adopted Balanced Governance?

The Clark County School District Board of Trustees formally adopted Balanced Governance™ as their governance model on February 10, 2017. Prior to this date, the Board of School Trustees worked under Policy Governance™ for the past 16 years. With the change from Policy Governance™ to Balanced Governance™, a new way of thinking must occur. Balanced Governance™ supports, as well as promotes balance and discourages micromanaging or rubber-stamping behaviors from the Board. For example, Balanced Governance™ seeks a middle ground between overly centralized and decentralized control from the Board. The Balanced Governance™ approach goes beyond establishing District-end goals or approving management crafted policy with Board input. It allows a Board to set and monitor high end-goals for student learning and to understand the means necessary to attain those goals. This governance model teaches Boards to use detailed knowledge of learning and teaching to better engage with community stakeholders.

Dr. Thomas Alsbury and Phil Gore, Editors of *Improving School Board Effectiveness: A Balanced Governance Approach*, discuss how Board members can contribute to the central goal of improving student's outcomes. Dr. Alsbury is working with the Clark County School District Board of Trustees and will continue to provide guidance on the proper implementation of the Balanced Governance™ model.
