

She doesn't hesitate to attend city council meetings concerning various issues.

The love that she has for people is truly a gift from God. She is the pastor of Anointed Tabernacle Church, 3050 Holly Ave., LV, NV, 89106 (previously named Miracle Faith Temple on Bonanza in the Moulin Rouge Center). Prior to that, she served as the interim pastor of Pilgrim Rest Baptist Church. Pastor Gaston is 83 years of age and continues to be an advocate for all people. She has a no-cost feeding program at her home where people can come to get produce, vegetables, pastries and much more. Her church, Anointed Tabernacle also has a branch of ministry that helps to feed the homeless.

Upon his passing he was recognized for his commitment and achievements as a supervisor over the Parks and Recreation and street sweeping department for over 25 years. Almary was a member of the parent teacher association in the many different schools that her children attended.

Pastor Gaston was also a room mother assisting in many different classrooms where needed, especially Highland Elementary School, know known as Kermit R. Booker Elementary school.
