Call for Nominations for Non-Instructional Facilities

Nominations will be accepted through June 1, 2015, to name 17 non-instructional facilities within the Clark County School District.

The School Name Committee will consider applications following the guidelines found in Clark County School District Policy [7223](#), Naming of Schools and Education-Related Facilities. The policy states *“Nonschool facilities may be named for outstanding individuals who have made an exceptional contribution in the advancement of education in Clark County and have consistently demonstrated positive moral character.”*

Further, Policy 7223 establishes the following guidelines for the School Name Committee when considering names for facilities:

1. Names of distinguished citizens or former District employees may be considered to honor or memorialize an individual in “extraordinary circumstances” which may be defined as including, but not limited to:
 - Loss of life in the performance of service to benefit or support the Clark County School District.
 - Individual actions that are determined to be beyond customary expectation that result in extraordinary benefit to the Clark County School District students, staff, and community members.
2. Names of District personnel will not be considered while actively employed either full-time, part-time, or as a consultant to the Clark County School District, nor for two years from the last day of employment.
3. Names of Board members may not be considered while actively serving on the Board of School Trustees, in accordance with NRS 338.200, nor for two years from the last day of service as a Clark County School District trustee.

4. A facility name will not be recommended if an existing CCSD facility or portion of a CCSD facility has already been named for the nominee, unless the nominee requests rescinding the previously named portion of facility prior to acceptance of the new school or new facility namesake honor.
5. Names of elected officials will not be considered while they are actively serving in public office.
