Most of us females have experienced at least some degree of harassment from teenage boys who make disrespectful/degrading comments about our bodies. This is uncomfortable and unwelcome and I am grateful we have separate bath/locker rooms or I cannot imagine how unrelenting and traumatizing the harassment would be. Most girls my age self-conscious enough, even when they are fully clothed, and it would cause severe mental distress for us to be forced to undress in front of the boys who ogle us and draw unwanted attention to our bodies. Special considerations might be made for transgender students, but this is not who I am talking about. I'm concerned this policy would open floodgates for boys who are NOT LGBTQ, but who are messing around, to enter girls' bath/locker rooms. This policy which might be meant to stop bullying of certain students would allow more bullying. Teachers and admin would not be able to do anything to stop this because they would fear losing their jobs if they are accused of handling anything the wrong way. I will feel extremely scared and unsafe at school if this is the case. Please let schools continue to handle transgender situations on an individual basis. Transgender bathrooms can be added to accommodate GD students without stripping everyone else's privacy away. Please do not enforce a blanket policy that will allow very serious bullying and harassment to occur on a mass scale.</p>

				N	Concerned the work group/committee inappropriately attempted to interpret and apply state law. Handout states the committee intends to create policy related to restroom accessibility. Instead of stating the issue needs to be addressed in light of protections set forth in NRS 651.070, the committee boldly states NRS 651.070 "requires students have access to the restroom of the gender they identify with." I reviewed NRS 651.070 and see no such requirement in its language; nor have I located any Nevada Supreme Court case which interprets NRS 651.070 to encompass such a requirement. This must mean the committee members independently determined NRS 651.070 provides such a specific right. The committee is not made up of elected legislators or judges. The committee intends to interpret state law and draft policies according to its interpretation. If CCSD desire clarity on their legal obligations and responsibilities in relation to the fair and equitable treatment of transgender students, they should lobby their lawmakers to provide statutory clarification. What CCSD cannot do is usurp the power to mold and interpret law and policy unless given such right from the Legislature. Although our system may not provide a solution within the timetable CCSD prefers, such cannot be used as an excuse for CCSD (and the committee) to write its own laws.
