

## CCSD MTSS STUDENT BEHAVIOR INCIDENT DEFINITIONS

**ABSENCE** – Not present; missing. Elementary students = Missing more than 115 minutes (half day absence) or 225 minutes (full day absence) of scheduled instruction. Secondary students = Missing more than 30 minutes of scheduled instruction. See Truancy for unexcused absences. *Major; Resolutions: L3-L5.*

- *NOTE: Progressive response resolutions utilized by site staff*

**ACCEPTABLE USE POLICY** – Any unauthorized, unacceptable, or inappropriate, use of computer activities, access, software, equipment; and/or any activity that affects or disrupts, the school or CCSD computer hardware, software, or computer systems. May include law enforcement involvement. Minor Offenses = Accessing gaming, music, social media, or non-approved sites using District equipment. Major Offenses = Accessing dangerous/violent, illegal, indecent, offensive, pornographic, solicitation, or threatening sites using District equipment; Hacking (altering, destroying, or modifying school or District files, programs, or software); Pirating (copying/downloading school or District programs or software for personal use). NOTE: Hacking and Pornography qualify as immediate discretionary referrals. *Minor; Resolutions 1-3: Progressive response resolutions utilized by site staff Resolutions; Major; Resolutions 3-5: Required Parent Conference or SWI, Suspension, Behavior School Referral, Discretionary Expulsion Recommendation.*

**AGGRESSIVE BEHAVIOR** – Hostile and/or destructive behavior that is reactionary and impulsive and socially inappropriate. *Minor; Resolutions: L1-L3.*

- *NOTE: More intensive behavior incidents should be labeled with a more appropriate behavior incident title.*

**ALCOHOL - DISTRIBUTION** – Any sale, distribution, sharing, or possession with intent to distribute, any form or amount of alcoholic beverages or substances represented to be alcohol. *Urgent; Resolutions: L5-L6.*

- *NOTE 1: The student and a parent or guardian must attend and complete CCSD's Substance Abuse Awareness Program (SAAP).*
- *NOTE 2: Students who distribute alcohol MUST be recommended for expulsion.*

**ALCOHOL - POSSESSION (1<sup>st</sup> offense)** – First time possession of alcoholic beverages or substances represented to be alcohol. *Major; Resolutions: L3-L5.*

- *NOTE 1: The student and a parent or guardian must attend and complete CCSD's Substance Abuse Awareness Program (SAAP).*
- *NOTE 2: The principal or designee, will for the first such incident, take appropriate disciplinary action other than recommending removal.*

**ALCOHOL - POSSESSION/USE, REPEATED** – Second (and subsequent) possession of alcoholic beverages or substances represented to be alcohol. *Urgent; Resolutions: L5-L6.*

- *NOTE 1: The student and a parent or guardian must attend and complete CCSD's Substance Abuse Awareness Program (SAAP).*
- *NOTE 2: Students who possess alcohol for a second (and subsequent) time MUST be recommended for expulsion.*

**ALCOHOL - USE (1<sup>st</sup> offense)** – First time use of alcohol beverages or substances represented to be alcohol. *Major; Resolutions: L3-L5.*

- *NOTE 1: The student and a parent or guardian must attend and complete CCSD's Substance Abuse Awareness Program (SAAP).*
- *NOTE 2: The principal or designee, will for the first such incident, take appropriate disciplinary action other than recommending removal.*

**ARSON** – Intentionally setting fire, or attempting to set fire, or intentionally engaging in *malicious* conduct which may reasonably be foreseen to set fire to property of another, participating in, or encouraging another person to participate in such conduct. *Major; Resolutions: L3-L5.*

- *NOTE: May be subject to restitution and law enforcement involvement.*

**ASSAULT - STAFF** – Attempt to cause physical injury intentionally or behave in such a way as could reasonably cause physical injury to a person or group of persons. May involve law enforcement. *Major; Resolutions: L3-L5.*

- *NOTE: May be subject to restitution and law enforcement involvement.*

**ASSAULT - STUDENT** – Attempt to cause physical injury intentionally or behave in such a way as could reasonably cause physical injury to a person or group of persons. May involve law enforcement. *Major; Resolutions: L3-L5.*

- *NOTE 1: May be subject to restitution and law enforcement involvement.*

- *NOTE 2: Subject to bullying protocol as per NRS 388.122; see Student Behavior Incident Guidelines for more details.*

**AUTO MISUSE** – Inappropriate use of an automobile on school property or during school events. *Major; Resolutions: L3-L5.*

**BATTERY - STAFF** – Any willful and unlawful use of force or violence against a CCSD employee. *Urgent; Resolutions: L5-L6.*

- *NOTE: Students who commit battery on a school employee MUST be recommended for expulsion.*

**BATTERY - STUDENT** – Any willful and unlawful use of force or violence against a CCSD student; see also Hitting; Fighting. *Major; Resolutions: L3-L5.*

- *NOTE 1: May be subject to law enforcement involvement.*
- *NOTE 2: Subject to bullying protocol as per NRS 388.122; see Student Behavior Incident Guidelines for more details.*
- *NOTE 3: Incident titles to be used by administrators only.*

**BATTERY - STAFF WITH INJURY** – Any willful and unlawful use of force or violence against a CCSD employee resulting in injury. *Urgent; Resolutions: L5-L6.*

- *NOTE: Students who commit battery on a school employee MUST be recommended for expulsion and may be subject to law enforcement involvement.*

**BATTERY - STUDENT WITH INJURY** – Any willful and unlawful use of force or violence against a CCSD student resulting in significant injury, where a clear imbalance of power has been established. *Urgent; Resolutions: L5-L6.*

- *NOTE 1: Students who commit battery on a student may be recommended for expulsion and may be subject to law enforcement involvement.*
- *NOTE 2: Subject to bullying protocol as per NRS 388.122; see Student Behavior Incident Guidelines for more details.*

**BULLYING** – Written, verbal, and/or electronic expressions or physical acts or gestures, or any combination thereof, that are directed at a person or group of persons, or a single severe and willful act or expression, that is directed at a person or group of persons; types of bullying include: Battery-Student; Battery-Student with Injury; Blackmail; Blocking Access; Cyberbullying; Discriminatory Harassment; Extortion; Obscene/Offensive Materials of Others–Distribution; Obscene/Offensive Materials of Others–Possession; Physical Threat/Assault-Staff/Non-School Employee; Physical Threat/Assault-Student; Sexting; Sexual Assault; Sexual Battery; Sexual Exploitation; Sexual Harassment; Sexual Intimidation; Stalking; Verbal Threat-Staff; Verbal Threat-Student; see also Cyberbullying. *Major; Resolutions: L3-L5.*

- *NOTE 1: May be subject to law enforcement involvement.*
- *NOTE 2: Subject to bullying protocol as per NRS 388.122; see Student Behavior Incident Guidelines for more details.*
- *NOTE 3: Incident titles to be used by administrators only.*

**BUS INFRACTION** – Refusal to obey *district* bus regulations, and/or any action which creates a safety hazard or distracts the attention of the driver. *(See Student Behavior Incident Guidelines for more details.) Major; Resolutions: L3-L5.*

- *NOTE 1: Behavior incident resolutions are pre-determined by transportation personnel.*
- *NOTE 2: May be subject to law enforcement involvement.*
- *NOTE 3: Incident titles to be used by administrators only.*

**CAMPUS DISRUPTION** – Acts that cause substantial disruption of learning opportunities or reckless conduct that threatens the safety of others, including school evacuations, lock-downs, riots, sit-downs, picketing, and/or disruptions that cause interruptions to the school’s function; see also Disregard of Rules/Regulations. *Major; Resolutions: L3-L5.*

**CHEATING** – Obtaining or attempting to obtain, or aiding another to obtain credit for work, or any improvement in evaluation of performance, by any dishonest or deceptive means. *Minor; Resolutions: L1-L3.*

**CLASS DISRUPTION** – Acts that interrupt or disrupt the learning opportunities of others. *Minor; Resolutions: L1-L3.*

**CLOSED CAMPUS** – The unauthorized leaving of school campus during the school day; leaving school grounds during the course of the regularly scheduled school day without permission of a parent and school principal or designee. *Major; Resolutions: L3-L5.*

- *NOTE: An elementary student may not be removed from school for this behavioral incident.*

**CONTROLLED SUBSTANCE - DISTRIBUTION** – Any sale, distribution, or sharing of any form or amount of drugs/controlled substances or substances represented to be drugs/controlled substances. *Urgent; Resolutions: L5-L6.*

- *NOTE 1: The student and a parent or guardian must attend and complete CCSD’s Substance Abuse Awareness Program (SAAP).*

- *NOTE 2: Students who distribute a controlled substance MUST be recommended for expulsion and may be subject to law enforcement involvement.*

**CONTROLLED SUBSTANCE - POSSESSION** (1<sup>st</sup> offense) – Possession of drugs/controlled substances or substances represented to be drugs/controlled substances. *Major; Resolutions: L3-L5.*

- *NOTE 1: The student and a parent or guardian must attend and complete CCSD's Substance Abuse Awareness Program (SAAP).*
- *NOTE 2: The principal or designee, will for the first such incident, take appropriate disciplinary action other than recommending removal (behavior school or expulsion) and may be subject to law enforcement involvement.*

**CONTROLLED SUBSTANCE - POSSESSION WITH INTENT** – Possession of drugs/controlled substances with the intent to sell, distribute, or share. *Urgent; Resolutions: L5-L6.*

- *NOTE 1: The student and a parent or guardian must attend and complete CCSD's Substance Abuse Awareness Program (SAAP).*
- *NOTE 2: Students who possess a controlled substance with the intent to distribute MUST be recommended for expulsion and may be subject to law enforcement involvement.*

**CONTROLLED SUBSTANCE - POSSESSION/USE, REPEATED** – Possession of drugs/controlled substances or substances represented to be drugs/controlled substances on more than one occasion while enrolled in CCSD. *Urgent; Resolutions: L5-L6.*

- *NOTE 1: The student and a parent or guardian must attend and complete CCSD's Substance Abuse Awareness Program (SAAP).*
- *NOTE 2: Students who possess a controlled substance on more than one occasion MUST be recommended for expulsion and may be subject to law enforcement involvement.*

**CONTROLLED SUBSTANCE - USE** (1<sup>st</sup> offense) – The second violation of use of drugs/controlled substances or substances represented to be drugs/controlled substances. *Major; Resolutions: L3-L5.*

- *NOTE 1: The student and a parent or guardian must attend and complete CCSD's Substance Abuse Awareness Program (SAAP).*
- *NOTE 2: The principal or designee, will for the first such incident, take appropriate disciplinary action other than recommending removal (behavior school or expulsion) and may be subject to law enforcement involvement.*

**CYBERBULLYING** – Bullying through the use of electronic communication; see also Bullying. *Major; Resolutions: L3-L5.*

- *NOTE 1: May be subject to law enforcement involvement.*
- *NOTE 2: Subject to bullying protocol as per NRS 388.122; see Student Behavior Incident Guidelines for more details.*
- *NOTE 3: Incident titles to be used by administrators only.*

**DISHONESTY** – A fraudulent or deceitful act or statement. *Minor; Resolutions: L1-L3.*

**DISREGARD OF RULES/REGULATIONS** – An act or acts that cause a minor disorder in a localized area (such as hallway, cafeteria, classroom); a minor infraction that interrupts any school activity or function outside of a classroom; see also Campus Disruption. *Minor; Resolutions: L1-L3.*

- *NOTE1: Although the majority of these incidents are handled by office staff, including administration, this is still a minor behavior incident and should be handled accordingly.*
- *NOTE2: No other behavior incident titles may be incorporated into this behavior incident title, including but not limited to, dress code violation-major, dress code violation-minor, dress code violation-non-dress PE; nuisance item; personal communication device; tardy; tardy lockouts/sweeps; leftover student*

**DRESS CODE VIOLATION** – Failure to observe the school's dress code as defined in CCSD Regulation 5131 Dress and Appearance (*See Student Behavior Incident Guidelines for more details.*) *Minor dress code violations are those that can be immediately rectified causing the student to not miss classroom instruction; Resolutions: L1-L3; Major are those that cannot be immediately rectified causing the student to miss classroom instruction; Resolutions: L3-L5.*

- *NOTE: A student may not be removed from school for this behavioral incident.*

**DRESS CODE VIOLATION-NON-DRESS PE** – Non-compliance with the required, school physical education uniform. *Minor; Resolutions: L1-L3.*

- *NOTE: A student may not be removed from school for this behavioral incident.*

**DRUG PARAPHERNALIA** – Equipment, products, and materials, of any kind which are used, intended for use, or designed for use, in planting, propagating, cultivating, growing, harvesting, manufacturing, compounding, converting, producing, processing,

preparing, testing, analyzing, packaging, repackaging, storing, concealing, containing, injecting, ingesting, inhaling, or otherwise introducing into the human body a controlled substance. *Major; Resolutions: L3-L5.*

- *NOTE 1: The student and a parent/guardian must attend and complete CCSD's SAAP.*
- *NOTE 2: The principal or designee, will for the first such incident, take appropriate disciplinary action other than recommending expulsion. Student may be subject to law enforcement involvement.*

**DRUG TEST VIOLATION** – A positive test resulting from the presence of any drug/controlled substance which an individual is prohibited from selling, offering to sell, possessing, giving, exchanging, using, distributing, or purchasing under State or Federal Law; May also include prescribed and/or over-the-counter drugs being used in any way other than for medical purposes in accordance with the directions for use provided for in the prescription or by the manufacturer. The principal or designee, will for the first such incident, take appropriate disciplinary action other than recommending removal. The student and a parent/guardian must attend and complete CCSD's Substance Abuse Awareness Program (SAAP). *Major; Resolutions: L3-L5.*

- *NOTE 1: May be subject to law enforcement involvement.*
- *NOTE 2: Site determination for 1st Offense (excluding a Behavior School Referral or Expulsion Recommendation), Discretionary Expulsion Recommendation (subsequent offenses).*

**ELECTRONIC SMOKING DEVICE - USE** – Use of any such electronic smoking device, whether manufactured, distributed, marketed, or sold as an electronic cigarette, electronic cigar, electronic cigarillo, electronic pipe, electronic hookah, vape pen or any other product name or descriptor that resembles smoking, which can be used to deliver an inhaled dose of nicotine, juice, THC, any drugs/controlled substances, or any other substances to the user on any CCSD properties or part(s) thereof, or at any school sponsored event, activity, or entity. *Major; Resolutions: L3-L5.*

- *NOTE 1: For incidents involving drugs/controlled substances, the student and a parent or guardian must attend and complete CCSD's Substance Abuse Awareness Program (SAAP).*
- *NOTE 2: The principal or designee, will for the first such incident, take appropriate disciplinary action other than recommending removal (behavior school or expulsion) and may be subject to law enforcement involvement.*
- *NOTE 3: Students who use drugs/controlled substances or substances represented to be drugs/controlled substances MUST be recommended for expulsion using the appropriate Controlled Substance title and may be subject to law enforcement involvement.*

**EXTORTION** – Solicitation of property, money, information, or something of value from another person, sometimes in exchange for protection, by force or threat of violence through intimidation, property damage, harm to reputation, or an unfavorable action; see also Blackmail. *Major; Resolutions: L3-L5.*

- *NOTE 1: May be subject to law enforcement involvement.*
- *NOTE 2: Subject to bullying protocol as per NRS 388.122; see Student Behavior Incident Guidelines for more details.*
- *NOTE 3: Incident titles to be used by administrators only.*

**FALSE REPORTS/ACCUSATIONS** – Knowingly and/or willfully making reports or statements (written or verbal) falsely accusing others of wrong actions or falsifying school records; falsifying, misrepresenting, omitting, or erroneously reporting information regarding instances of alleged inappropriate behavior by a student, teacher, administrator, other school employee, or adult toward a student. *Major; Resolutions: L3-L5.*

- *NOTE: May be subject to law enforcement involvement.*

**FIGHTING** – Engaging in physical contact for the purpose of inflicting harm on another person; see also Battery. *Major; Resolutions: L3-L5.*

- *NOTE: May be subject to law enforcement involvement.*

**FIRE ALARM PULL** – Falsely pulling the school's fire alarm system. *Major; Resolutions: L3-L5.*

- *NOTE: May be subject to law enforcement involvement.*

**FORGERY** – The creation of a false written document or alteration of a genuine one and/or writing and using the signature or initials of another person with the intent to defraud. *Major; Resolutions: L3-L5.*

**GAMBLING** – Staking or risking by any student of something of value upon the outcome of a contest of others, a sporting event, or a game subject to chance for the purpose of exchanging money and/or other valuables based upon that outcome. *Major; Resolutions: L3-L5.*

- *NOTE: May be subject to law enforcement involvement.*

**GANG INVOLVEMENT** – Engaging in activity that encourages participation in a criminal gang or facilitates illegal acts of a criminal gang. *Major; Resolutions: L3-L5.*

- *NOTE: May be subject to law enforcement involvement.*

**GRAFFITI** – Marking or defacing any CCSD properties or part(s) thereof or any other property without permission that can be immediately rectified; see also Vandalism. *Minor graffiti violations are easily correctable or able to be removed with ease; Resolutions: L1-L3; Major graffiti violations are not easily correctable or not able to be removed with ease; Resolutions: L3-L5.*

- *NOTE: May be subject to restitution and law enforcement involvement.*

**HABITUAL DISCIPLINARY PROBLEM** – A student will be deemed a habitual disciplinary problem if the school in which the pupil has enrolled has written evidence which documents that in one school year that the student has: threatened or extorted, or attempted to threaten or extort another student, or a teacher, or other personnel employed by the school two times, or has a record of five (5) suspensions of three days or more, from school for any reason. Prior to labeling a student a Habitual Disciplinary Problem, the parent/guardian of the student must be given the opportunity to engage in a corrective action plan for the student. If the parent/guardian refuses to participate and/or does not follow through on the plan, and the other conditions exist, the student may then be labeled Habitual Disciplinary Problem. *Urgent; Resolutions: L5-L6.*

- *NOTE: Contact Education Services Division (ESD) for specific guidance prior to submitting any HDP recommendation.*

**HABITUAL TRUANCY CITATION** – Three or more unapproved/unexcused absences (on separate days) from school. *Major; Resolutions: L3-L5*

- *NOTE 1: Habitual truants are referred to law enforcement for the issuance of a citation. Students 14-17 years of age will also receive DMV Administrative Sanctions; see also DMV Administrative Sanctions in Student behavior Incident Guidelines.*
- *NOTE 2: A student may not be removed from school for this behavioral incident.*

**HAZING** – Intentionally or recklessly endangering the physical health of another person for the purpose of initiation into or affiliation with a student organization, academic association, or athletic team of a school. *Major; Resolutions: L3-L5*

**HITTING** – Intentionally and aggressively bringing one's hand or instrument into contact with (someone or something) quickly and forcefully in order to cause harm, distress, or damage (to someone or something); see also Fighting; Battery. *Minor; Resolutions: L1-L3; Major; Resolutions: L3-L5*

**HORSEPLAY** – Engagement in rough or boisterous activities with the absence of animosity or a willingness to inflict bodily harm. *Minor; Resolutions: L1-L3.*

- *NOTE: As warranted, more intensive aggressive behaviors should be logged a more appropriate behavior incident title.*

**IMMORAL CONDUCT** – Engagement in sexual activity between two or more consenting individuals on any CCSD properties or part(s) thereof. *Major; Resolutions: L3-L5*

- *NOTE: May be subject to law enforcement involvement.*

**IMMUNIZATION VIOLATION** – Failure to provide appropriate and/or up-to-date immunization records, despite documented requests to do so. *Major; Resolutions: L3-L5*

**INFORMATION ONLY** (office use only) – Details about a situation, person, and/or event; non-punitive.

- *NOTE: A student may not be removed from school for this behavioral incident.*

**INSUBORDINATE** – Initial refusal to comply with reasonable directions or commands of authorized school personnel or designees. *Minor; Resolutions: L1-L3.* Willful defiance or refusal to comply with repeated reasonable directions or commands of authorized school personnel or designees. *Major; Resolutions: L3-L5*

**LEFTOVER STUDENT** – Missing the bus, not being picked-up after school, or not having a way home. *Major; Resolutions: L3-L5*

- *NOTE 1: Follow After School Care Plan.*
- *NOTE 2: A student may not be removed from school for this behavioral incident.*

**MALTREATMENT OF OTHERS** – A report of, or witness to, or suspicion of a student being repeatedly mean, rude, or cruel towards another student that continues after the alleged victim has communicated that he/she would like the behavior to stop. *Major; Resolutions: L3-L5.* Minor maltreatment of others can easily be handled by school staff. *Minor; Resolutions L1-L3.*

- *NOTE 1: A bullying investigation MUST be opened if any part of the initial investigation for this incident falls under NRS 388.122. See bullying section of Student Behavior Incident Guidelines for more details.*
- *NOTE 2: May be subject to law enforcement involvement.*

**NO SHOW - DETENTION** – Failure to present oneself to a detention as requested/required/intended without proper authorization, notification and/or rescheduling. *Minor; Resolutions: L1-L3*

- *NOTE 1: Teacher should make every attempt to assign an alternative resolution and/or reschedule.*
- *NOTE 2: A second “No Show” may result in a major behavior incident referral.*

**NO SHOW - OFFICE/WHEREABOUTS UNKNOWN** – Failure to present oneself to an office/appointment/meeting as requested/required/intended without proper authorization, notification and/or rescheduling. *Major; Resolutions: L3-L5*

**NUISANCE ITEM** – Items which are disruptive to the educational/learning environment. *Minor; Resolutions: L1-L3.*

- *NOTE 1: These items may be confiscated, but MUST be stored by an administrator; items should only to be returned to the student’s parents/legal guardians.*
- *NOTE 2: The school will not be held responsible for lost or stolen items.*
- *NOTE 3: A student may not be removed from school for this behavioral incident.*

**OUT OF DISTRICT REMOVAL** – Student enrolling in CCSRD with pending discipline from another school district, charter school, or private school. *Major; Resolutions: L3-L5; see NOTE 2.*

- *NOTE 1: School MUST contact the Director of the Department of Pupil Personnel Services, CCSRD, immediately.*
- *NOTE 2: Resolution depends on behavior infraction.*

**OVER-THE-COUNTER MEDICATION MISUSE** – The inappropriate use of a psychoactive substance for purposes other than its intended medicinal purpose; see also CONTROLLED SUBSTANCE-POSSESSION; CONTROLLED SUBSTANCE-USE. *Major; Resolutions: L3-L5.*

- *NOTE 1: The student and a parent or guardian must attend and complete CCSRD’s Substance Abuse Awareness Program (SAAP).*
- *NOTE 2: The principal or designee, will for the first such incident, take appropriate disciplinary action other than recommending removal (behavior school or expulsion) and may be subject to law enforcement involvement.*

**PERSONAL COMMUNICATION DEVICE** – The unauthorized use of cell phones, laptops, tablet computers, or similar electronic devices on CCSRD property during prohibited times; visible possession or use of communication devices during prohibited times, within the school building, or on a school bus, except as permitted by school administration for instructional purposes. *Minor; Resolutions: L1-L3.*

- *NOTE: A student may not be removed from school for this behavioral incident.*

**PLAGIARISM** – Representing another person’s work or ideas as one’s own without giving credit to the proper source and submitting it for any purpose; appropriating the literary composition of another author, or excerpts, ideas, or passages therefrom, and passing the material off as one's own creation. *Minor; Resolutions: L1-L3.*

**PUBLIC DISPLAY OF AFFECTION** – Acts of physical intimacy in the view of others deemed inappropriate for the school environment. *Minor; Resolutions: L1-L3.*

**ROBBERY** – Unlawfully taking property with the intent to permanently deprive the person of that property through the use of force, fear, or intimidation, or the threat of force. *Major; Resolutions: L3-L5*

- *NOTE: May be subject to restitution and law enforcement involvement.*

**SEXUAL ASSAULT** – A continuum of conduct from forcible intercourse to nonphysical forms of pressure that compel individuals to engage in sexual activity against their will. *Urgent; Resolutions: L5-L6.*

- *NOTE 1: Students involved in Sexual Assault may be recommended for expulsion and may be subject to law enforcement involvement.*
- *NOTE 2: Subject to bullying protocol as per NRS 388.122; see Student Behavior Incident Guidelines for more details.*

**SEXUAL HARASSMENT** – Verbal, written, visual or physical conduct of a sexual nature directed at an individual, or against a particular group, because of that person's or group's gender, or based on gender stereotypes or manifestation, where that behavior is unwelcome (behaviors which include, but are not limited to, unwelcome sexual advances or gestures, requests for sexual favors, sexually offensive slurs, electronic messages such as email, text messages, sexually offensive drawings or publications directed towards another person), whether there is a pattern of harassing behavior or a single significant incident. *Major; Resolutions: L3-L5.*

- *NOTE 1: May be subject to law enforcement involvement.*
- *NOTE 2: Subject to bullying protocol as per NRS 388.122; see Student Behavior Incident Guidelines for more details.*

- *NOTE 3: Incident titles to be used by administrators only.*

**STALKING** – The act of willfully and repeatedly following and/or harassing another person, either in person or online, in circumstances that would cause a reasonable person to fear for their safety. *Major; Resolutions: L3-L5.*

- *NOTE 1: May be subject to law enforcement involvement.*
- *NOTE 2: Subject to bullying protocol as per NRS 388.122; see Student Behavior Incident Guidelines for more details.*
- *NOTE 3: Incident titles to be used by administrators only.*

**TARDY LOCKOUTS/SWEEPS** – Students who are gathered to receive an immediate disciplinary consequence for their tardiness. *Major; Resolutions: L3-L5.*

- *NOTE: A student may not be removed from school for this behavioral incident.*

**TARDY** – Not being in the assigned instructional location prior to the scheduled start time; arriving to class after the scheduled start time with a valid excuse. *Minor; Resolutions: L1-L3.*

- *NOTE: A student may not be removed from school for this behavioral incident.*

**TESTING VIOLATION-HIGH-STAKES TEST** – Participation (or attempted participation) in receiving and/or providing direct/indirect assistance with responses to test questions, tampering with responses after designated time allotment; falsifying responses, viewing secure test content before, during, or after test administration, duplicating, recording, and/or electronically capturing confidential test content, engaging in conduct described in the items listed above or in any other serious violation of test security and confidentiality before, during, or after test administration. *Major; Resolutions: L3-L5*

- *NOTE: May be subject to law enforcement involvement.*

**THEFT** – Unlawfully taking property with the intent to permanently deprive the person of that property. *Major; Resolutions: L3-L5*

- *NOTE: May be subject to restitution and law enforcement involvement.*

**THREAT - SCHOOL** – A statement of an intention to inflict pain, injury, death, damage, or other hostile action against a specific CCSD school or the occupants of a specific CCSD school. *Major; Resolutions: L3-L5*

- *NOTE 1: A threat assessment is required for all instances of threatening behavior.*
- *NOTE 2: May be subject to law enforcement involvement.*

**THREAT - STAFF** – A statement of an intention to inflict pain, injury, death, damage, or other hostile action against a CCSD staff member. *Major; Resolutions: L3-L5*

- *NOTE 1: A threat assessment is required for all instances of threatening behavior.*
- *NOTE 2: May be subject to law enforcement involvement.*

**THREAT - STUDENT** – A statement of an intention to inflict pain, injury, death, damage, or other hostile action against a CCSD student. *Major; Resolutions: L3-L5*

- *NOTE 1: A threat assessment is required for all instances of threatening behavior.*
- *NOTE 2: May be subject to law enforcement involvement.*

**TOBACCO - POSSESSION** – Possession of tobacco on any CCSD property or at any school sponsored event, activity, or entity. *Major; Resolutions: L3-L5*

**TOBACCO - USE** – Use of tobacco on any CCSD properties or part(s) thereof, or at any school sponsored event, activity, or entity. *Major; Resolutions: L3-L5*

**TRESPASSING** – Unauthorized presence on any CCSD properties or part(s) thereof, including any in which they are not enrolled or currently on RPC, suspended or expelled, at a school sponsored activity/event without express prior permission from the principal or designee, and/or a refusal to leave said property after having been directed to do so by any authorized personnel. *Major; Resolutions: L3-L5*

- *NOTE: May be subject to law enforcement involvement.*

**TRUANCY** – A student who is absent from school for one or more class periods during the school day without the written approval of his/her teacher or the principal of the school, unless the student is physically or mentally unable to attend (NRS 392.130). *Major; Resolutions: L3-L5*

- *NOTE: A student may not be removed from school for this behavioral incident.*

**UNACCEPTABLE LANGUAGE** – Use of language which is disruptive to the learning environment considered to be vulgar, abusive, profane, discriminatory, and/or indecent; any vocalization consisting of or including vulgarities, expletives, or words that are not age-appropriate; use of profanity not directed towards another individual. *Minor unacceptable language is not directed at an individual; Resolutions: L1-L3; Major unacceptable language is directed at an individual; Resolutions: L3-L5.*

**VANDALISM** – Willfully and maliciously destroying, defacing, or mutilating any CCSD properties or part(s) thereof or any other property; intentionally engaging in conduct which could reasonably result in destruction or damage to the property of another, including tagging; see also Graffiti. *Major; Resolutions: L3-L5*

- *NOTE: May be subject to restitution and law enforcement involvement.*

**VERBAL ABUSE** – The excessive use of language to undermine someone's dignity and/or security through insults and/or humiliation, in a sudden and/or repeated manner; see also Verbal Confrontation. *Major; Resolutions: L3-L5*

**VERBAL CONFRONTATION** – A disagreement between students consisting of words alone without action; see also Verbal Abuse. *Major; Resolutions: L3-L5.*

**WEAPONS - POSSESSION** – Possession of a firearm, including a weapon defined by the Gun-Free Schools Act as set forth below, or a Dangerous Weapon, which includes, without limitation, a blackjack, slungshot, billy, sand-club, sandbag, metal knuckles, dirk or dagger, a nunchaku, switchblade knife or trefoil, a butterfly knife or any other knife described in NRS 202.350, or any other object which is used, or threatened to be used, in such a manner and under such circumstances as to pose a threat of, or cause, bodily injury to person. Under NRS, while on school grounds, an Air Soft Gun, BB Gun, Paint Ball Gun, and Pellet Gun are all considered weapons. (See weapons definitions in Student Behavior Incident Guidelines for more details.) *Urgent; Resolutions: L5-L6*

- *NOTE 1: Principals may, in their discretion, take appropriate disciplinary action other than recommending expulsion for possession of prohibited weapons, except those listed above, which are not used under dangerous circumstances or in a threatening manner.*
- *NOTE 2: Students who possess, use, transmit, or conceal any operable or inoperable dangerous weapon listed above MUST be recommended for expulsion recommendation per NRS 392.466 and may be subject to law enforcement involvement.*

**WEAPONS - POSSESSION WITH THREAT** – Any statement of an intention to inflict pain, injury, damage, or other hostile action using a weapon against a student or staff member. (See weapons definitions in Student Behavior Incident Guidelines for more details.) *Urgent; Resolutions: L5-L6*

- *NOTE: Students who possess and use a weapon to threaten MUST be recommended for expulsion recommendation per NRS 392.466 and may be subject to law enforcement involvement.*

**WEAPONS - POSSESSION WITH INJURY** – Any willful and unlawful use of force or violence involving a weapon against a student or staff member resulting in injury. (See weapons definitions in Student Behavior Incident Guidelines for more details.) *Urgent; Resolutions: L5-L6*

- *NOTE: Students who possess and use a weapon resulting in injury MUST be recommended for expulsion recommendation per NRS 392.466 and may be subject to law enforcement involvement.*
