This position is responsible for reviewing all costs related to construction projects and confirming they comply with accounting principles, Clark County School District (CCSD) regulations and policies, state and federal laws, jurisdictional codes, and executed contracts. This position is directly responsible to the Coordinator IV, Construction Project Accountant Manager, Facilities Bond Fund Financial Management, Business and Finance Unit.

Essential Duties and Responsibilities

The list of Essential Duties and Responsibilities is not exhaustive and may be supplemented.

- 1. Reviews contractors' and subcontractors' billings for accuracy and completeness.
- 2. Reviews work orders, invoices, change orders, requisitions, purchase orders, and purchase card transactions related to construction projects.
- 3. Confirms contractor status.

- 4. Applies cost improvement findings from project reviews to future reviews to prevent future inefficiencies.
- 5. Manages compliance with terms and conditions of the contract(s), including items such as bonds, insurance, waivers, billing accuracy, etc.
- 6. Approves payment requests.
- 7. Confirms compliance with regulations, policies, and applicable state and federal laws.
- 8. Performs other duties related to the position, as assigned.

Position Expectations

- Knowledge of Generally Accepted Accounting Principles (GAAP) practices and procedures; Governmental Accounting Standards Board (GASB); and Financial Accounting Standards Board (FASB).
- 2. Familiarity with AIA contracts.
- 3. Knowledge of personal computers, software applications, and Microsoft and Google applications.
- 4. Possess analytical and problem-solving skills.
- 5. Possess negotiating skills.
- 6. Ability to manage more than one (1) project at a time.
- 7. Ability to work independently, exercising judgment, and maintaining confidentiality.
- 8. Excellent communication and interpersonal skills.
