Position Summary

The individual selected for this position will coordinate and provide specialized support for teachers and administrators in health and PE. In addition, the individual will plan, develop, and provide professional learning in the areas of health and PE curricula, instruction, and program support. The project facilitator will collaborate with local, regional, and state organizations, businesses, and institutions of higher education as well as Clark County School District divisions and departments including, but not limited to: the Human Resources Division (HRD); English Language learner Department (ELLD); Student Services Division (SSD); and Food Service Department, to promote consistency in professional learning activities in addressing District goals, initiatives, and objectives. The individual selected for this position will be expected to adhere to the District's *Professional Domains and Standards for Licensed Employees* and is responsible to the Director of K-12 Science, Health, and PE, Curriculum and Instruction Division (CID), Academic Unit (AU).

Essential Duties and Responsibilities

The list of Essential Duties and Responsibilities is not exhaustive and may be supplemented.

1. Plan and develop new and/or revised curricula for health and physical education.
 2. Assist the Coordinator of Health, PE, and Driver Education in the selection of teacher task forces and works with those task forces to create new and/or revised curricula, pacing of the curricula, and assessments.
 3. Plan, prepare, and facilitate professional learning activities to support teachers with the implementation of health and physical education curricula.
 4. Collaborate with a variety of divisions, departments, and institutions to provide teachers with resources that lead to improved student achievement.
 5. Communicate, collect data, and provide summary reports to the Coordinator of K-12 Health, PE, and Driver Education.
 6. Assist in assessing the effectiveness of assigned activities and in planning future projects.
 7. Provide support for all site-based and central office requests.
 8. Collaborate with state and local agencies promoting health and wellness.
 9. Maintain appropriate documentation of all project activities.
 10. Perform other related duties related to the position, as required.

3. Experience teaching health at the middle or high school level.
4. Training in leadership, workshop facilitation, and presentation skills for adult learners.
5. Knowledge and successful experience working with diverse student populations.
6. Experience in the effective implementation of instructional technology in and beyond the health and/or PE classroom.
7. Ability to work under pressure and meet deadlines.
