Position Summary

Under general supervision, troubleshoots, repairs, installs, and maintains fire alarms to the electronic component level.

Essential Duties and Responsibilities

The list of Essential Duties and Responsibilities is not exhaustive and may be supplemented.

- 1. Troubleshoots, repairs, and maintains microprocessor-based equipment to component level; installs fire alarm systems.
- 2. Initiates requests for shop supplies/equipment, as required.
- Serves as liaison between the Facilities Management Services Department, Construction Management, and the Clark County Fire Department, regarding fire alarm/safety issues.
- 4. Conducts annual/semi-annual fire alarm inspections.
- 5. Tests, inspects, and makes reports on new fire alarm installations/equipment.
- 6. Researches parts and equipment sources.
- 7. Communicates with Clark County School District (CCSD) staff, contractors, and vendors regarding equipment warranties.

- 8. Instructs CCSD staff on the use of fire/safety alarm systems.
- Creates and maintains records required by designated entities (state,
 Occupational Safety and Health Administration (OSHA), local fire departments,
 etc.); files all facility inspection reports with the State Fire Marshal's Office.
- 10. Reviews, plans, and/or designs fire alarm systems; assists in writing codecompliant specifications for new/existing facilities.
- 11. Assists Construction Management in maintaining accurate, updated as-built drawings and records.
- 12. Uses laptop computer to interface with fire alarm systems; maintains repair histories.
- 13. Uses electronic and microprocessor-based test equipment to troubleshoot, repair, and program fire alarm and voice evacuation systems.
- 14. Installs conduit and wiring.
- 15. Responsible for safe handling and disposal of hazardous materials.
- 16. Conforms to safety standards, as prescribed.
- 17. Performs other tasks related to the position, as assigned.

Distinguishing Characteristics

Involves diagnosing, repairing, and maintaining fire alarm systems and/or related equipment to the electronic component level.

Knowledge, Skills, and Abilities (Position Expectations)

- 1. Knowledge of computer applications.
- 2. Knowledge of electronics trade practices/procedures.
- 3. Knowledge of local, state, and federal fire codes.
- 4. Ability to recognize, understand, interpret, and apply all local, state, federal, and national codes/regulations, including OSHA, Uniform Building Code (UBC), Uniform Mechanical Code (UMC), Uniform Plumbing Code (UPC), National Fire Protection Association (NFPA), National Electrical Code (NEC), etc.
- 5. Ability to learn and apply work procedures.
- 6. Ability to provide in-service trainings on fire/safety alarm equipment.
- 7. Ability to meet predetermined deadlines.
- 8. Ability to read and interpret written/verbal instructions.
- Ability to read and interpret building blueprints, schematics, and wiring/logic diagrams.

- 10. Ability to operate hand/power tools and equipment.
- 11. Ability to distinguish color-coded wires.
- 12. Ability to safely move and relocate heavy objects.
- 13. Ability to plan and organize work.
- 14. Ability to work flexible hours/shifts.
- 15. Ability to work in confined spaces.
- 16. Ability to perform strenuous, physical work.
- 17. Ability to withstand heights and perform work safely.
- 18. Ability to work cooperatively with employees, contractors/vendors, and the public.
- 19. Ability to recognize/report hazards and apply safe work methods.
- 20. Possess physical and mental stamina commensurate with the responsibilities of the position.

Position Requirements

Education, Training, and Experience

- 1. High school graduation or other equivalent (General Educational Development (GED), foreign equivalency, etc.).
- 2. Four (4) years' experience in the installation, maintenance, and repair of fire alarm systems; or,
 - Two (2) years' formal training (trade school or coursework equivalent to an associate degree from an accredited college/university in electronics), and two (2) years' experience in the installation, repair, and maintenance of fire alarm systems.

Licenses and Certifications

- A valid driver's license that allows the applicant/employee to legally operate a motor vehicle in Nevada. License must be maintained for the duration of the assignment.
- Current driving history (dated within six (6) months from the date printed) issued by the Department of Motor Vehicles (DMV) at the time of application or Qualified Selection Pool (QSP) placement and at the time of interview prior to final selection.
- Safe driving record. Safe driving record must be maintained for the duration of the assignment.
- 4. Nevada State Fire Marshal Certificate of Registration, Type F. If certification is current in another state, the Nevada Registration must be obtained within three

- (3) months of hire into position. Certification must be maintained for the duration of the assignment.
- 5. Hold or be able to obtain District-issued forklift certification. If certification is not in possession at time of application or Qualified Selection Pool (QSP) request, it must be obtained within five (5) months of hire into position. Certification must be maintained for the duration of the assignment.

Preferred Qualifications

None specified.

Document(s) Required at Time of Application

- 1. High school transcript or other equivalent (GED, foreign equivalency, etc.).
- 2. College transcript(s) from an accredited college, university, or trade school, if applicable.
- 3. Copy of a valid driver's license that allows the applicant/employee to legally operate a motor vehicle in Nevada.
- 4. Copy of current driving history (dated within six (6) months from the date printed) issued by the DMV.
- 5. Safe driving record.
- 6. Nevada State Fire Marshal Certificate of Registration, Type F, if applicable.
- 7. CCSD-issued forklift certification, if applicable.
- 8. Specific documented evidence of training and experience to satisfy qualifications.

Examples of Assigned Work Areas

CCSD facilities – offices and schools (classrooms, gymnasiums, multipurpose rooms, auditoriums, cafeterias, etc.), construction sites, etc.

Work Environment

Strength

Medium/heavy - exert force of 50-100 lbs., occasionally; 25-50 lbs., frequently; 10-20 lbs., constantly.

Physical Demand

Frequent sitting, standing, walking, pushing, pulling, stooping, kneeling, crouching, reaching, handling, and repetitive fine motor activities. Hearing and speech to communicate in person, via video conference and computers, or over the telephone. Mobility to work in a typical office setting and use standard office equipment. Stamina to remain seated and maintain concentration for an extended period of time. Vision: Frequent near acuity, occasional far acuity, and color vision. Vision to read printed and online materials, Video Display Terminal (VDT) screens, or other monitoring devices.

Environmental Conditions

Varies from climate-controlled office settings to work outdoors with temperatures ranging from mild/moderate to extreme cold/heat. Exposure to noise levels ranging from moderate to loud for occasional to frequent time periods.

Hazards

Furniture, office equipment, communicable diseases, chemicals and fumes (as related to specific assignment), and power/hand-operated equipment and machinery (as related to specific assignment).

Examples of Equipment/Supplies Used to Perform Tasks

Forklifts, hand/power tools, ladders, soldering equipment, volt-ohm meters, audio generators, laptop computers, hand drills, drill presses, man-lifts, radio frequency/audio cable tracers, handheld radios, smartphones, etc.
