The main campus consists of nine buildings with existing air handlers that are to be renovated or removed and replaced as indicated on the drawings along with replacing the chiller(s), cooling tower, and boiler(s) systems. The existing building control system shall be removed and replaced with a new direct digital control (DDC) system. General construction work repair for walls, ceilings, concrete, and roofing shall be part of the project as described within the contract documents. Electrical work to replace service entrance switchboard equipment shall require coordination with the local power utility company and school management for meeting specific milestones. Temporary power systems shall be considered and coordinated with CCSD project manager. Temporary heating or cooling systems shall be considered during construction to maintain campus comfort.

Prequalified Bidders shall have a Nevada Contractor's License with the Classification of AB, B, B2 and C21.

The construction estimate for the project is: \$4,230,000.00
