The work consists of: The project includes the installation of site improvements and infrastructure to support a portable campus to be located on the southeast corner of Lamb and Kell in Clark County, Nevada. The site will be turned over to the Contractor with grading work complete and some portables in place. Contractor will be required to coordinate work with CCSD Maintenance forces working on the portables onsite during construction, and Lomie Heard Elementary School for work on the active playground and turf areas, student pick-up/drop-off traffic.

The scope of work includes but is not limited to: installation of concrete sidewalks and driveways; modifications to the existing landscape irrigation system; removal and replacement of existing landscape planting and groundcover; installation of new landscaping, fencing and gates; trenching and installation of electrical and low voltage conduit, domestic water piping, fire water piping, sewer piping; connection to Lomie G. Heard electrical main; patch and repair of work in playground, turf areas, driveways and sidewalks.
