The scope of work is to replace the topsoil, sod, and irrigation system of the existing grass play field area (approximately 1.5 acres on the north side of campus) The gravel underneath the portables and associated asphalt walks will be removed and replaced with sod. The irrigation system will include a new mainline, valves, laterals, rotors, and wiring to the existing controller. Upgrade the existing controller if necessary.
