The Work consists of: All HVAC improvements inclusive of replacing in kind: the cooling tower including pumps and controls as necessary; the school's HVAC Controls; the chiller and associated pumps, controls, and roof exhaust fans. Providing the following: ductless fan unit for kitchen; repairs to MZU equipment; ventilation for chiller room; chilled and hot water fan coil for chiller room; chemical treatment for internal hydronic pipe cleaning; PVC jacket around flue pipes of two water heaters. Remove evaporative coolers from chiller and boiler rooms. Remove hot water circulating pump at each MZU. Install 2 ductless units in two classrooms converted to computer labs.
