Replace Gym Bleachers Walter Johnson Junior High School Academy of International Studies MPID #0015020, PWP #CL-2021-227

The project consists of demolition and disposal of existing gymnasium bleachers and installation of new bleachers. Bleachers shall have gross seating of 1,188, net seats of 1,008, flex row, ADA spacing, auto folding aisle rails, auto folding end rails, 22" spacing, 3 aisles per bank, wood finished platforms, signature letters, pendent controlled UL listed power, no permanent cut outs, flex row ADA.

Prequalified Bidders shall have a Nevada Contractor's License with the Classification of C26b.
