 - c) Subcontractors previously listed on Document 00 43 36- Subcontractors Exceeding 5% Listing, must be re-listed on Document 00 43 36A – Subcontractors Exceeding 1% Listing.
3. Submit 00 43 46 B Expanded Subcontractor Listing to **infocpc@nv.ccsd.net**. Failure to comply within the required time limit may be cause for the Contractor to be deemed non-responsive.
