Pursuant NRS 338.1385, bids will be received at the Clark County School Contract, Procurement and Compliance, 1180 Military Tribute Place, Henderson, NV 89074 until **Tuesday, January 10, 2022, at 1:00 PM**, through the E-Builder bidding module and read aloud publicly for the furnishing of all labor and materials to perform the Work in conjunction with the construction of:

The scope project is to demo the existing small water cooled chiller, small cooling tower on the roof, pumps, accessible hydronic piping, air handling units (3), exhaust fan motor control center, lighting and air distribution system. The existing HVAC system will be replaced by (4) DX/gas rooftop package units with modulating exhaust fans, (3) units on the lecture hall and (1) on the dance classroom. Also included are a new concentric diffuser, new ductwork, (4) smoke detectors, ductwork system, and exhaust fan.

Prequalified Bidders shall have a Nevada Contractor's License with the Classification of C-21.
