The Roof Recover for the Ruthe Deskin Elementary School includes but is not limited to the recover of existing build-up roofs with 80 mil PVC. In addition, some auxiliary equipment such as roof ladders will be installed or replaced, some mechanical and electrical equipment will be removed or temporarily disconnected and reattached, and some existing ceilings to be removed and replaced throughout. Exterior scope of work includes recaulking of building exterior areas.
