#### AB 288: Transition from HSPE to New Graduation Requirements

#### Starting in 2014-15 school year:

- Students in grade 11 will participate in one state-mandated assessment of College and Career Readiness (CCR)—legislation does not define content of CCR outside of some references to the Common Core State Standards
- Participation in the grade 11 CCR assessment will be required for students to graduate with a regular or advanced diploma
- Passage of the CCR assessment will not be required for graduation with a regular diploma (could it be for or advanced diploma or post-secondary placement?)
- Students will participate in four end-of-course (EOC) assessments 2 in mathematics; 2 in English Language Arts
- Students must pass all four EOC exams at mandated cut scores to graduate with a regular or advanced diploma
- Retest opportunities must exist for the EOC exams
- Students with disabilities can opt out of CCR & EOC based on decision of Individualized Education Program (IEP) team (no regular diploma received)
- There are four anticipated vendors of interest for the Grade 11 CCR Assessment (alpha order):
  - o ACT
  - o Pearson
  - o SAT
  - Smarter Balanced
- Anticipated vendors of interest for the EOC Exams are unknown; there has been a
  working assumption in legislative testimony that Smarter Balanced will be selected for
  EOC so as to ensure vertical alignment with grade 3-8 assessments and opportunity to
  sufficiently collect and report growth model data
- Procurement processes will be dictated by test selection (RFP vs sole source contracting)

#### For the transition years, including 2013-2014 school year:

State Board must prescribe requirements for graduation for students who are in the 12<sup>th</sup> grade in 2013-14; 2014-15; and 2015-16.

- 1. For the **2013-2014** fiscal year, state Distributive School Account (DSA) funding for CCSD is \$5,457 per student, an increase of \$200 or 3.8 percent.
- 2. This level of DSA funding is consistent with estimates used to build the Board's 2013-2014 Final Budget, thus no significant changes will be needed (other than for the designated enhancements discussed below).
- 3. Funding the district's priorities as outlined in the 2013-2014 Final Budget will still be possible; in particular the funding of 793 additional teacher positions to reduce class size and the addition of 17 additional elementary assistant principal positions.
- 4. **No funding reductions** will be required in 2013-2014.
- 5. For the 2014-2015 fiscal year, state Distributive School Account (DSA) funding for CCSD is \$5,544 per student, an increase of \$87 or 1.6 percent.
- 6. Designated funding was added for additional pre-K, Reading Skills Development Centers, and Kindergarten programs at the 15 schools with the highest English language learner student populations.
- 7. Designated funding was added over the biennium to expand the number of allday Kindergarten programs to approximately 57 additional schools.
- 8. Designated funding was added over the biennium to reduce class sizes in Kindergarten programs to 21:1.

Note: This analysis is only based on publically available funding bills. Other than the DSA amounts which are included in SB422, no CCSD-specific details have been published by the State Department of Education. Thus, the estimates of the impact of designated funding enhancements are based off of very preliminary information.
