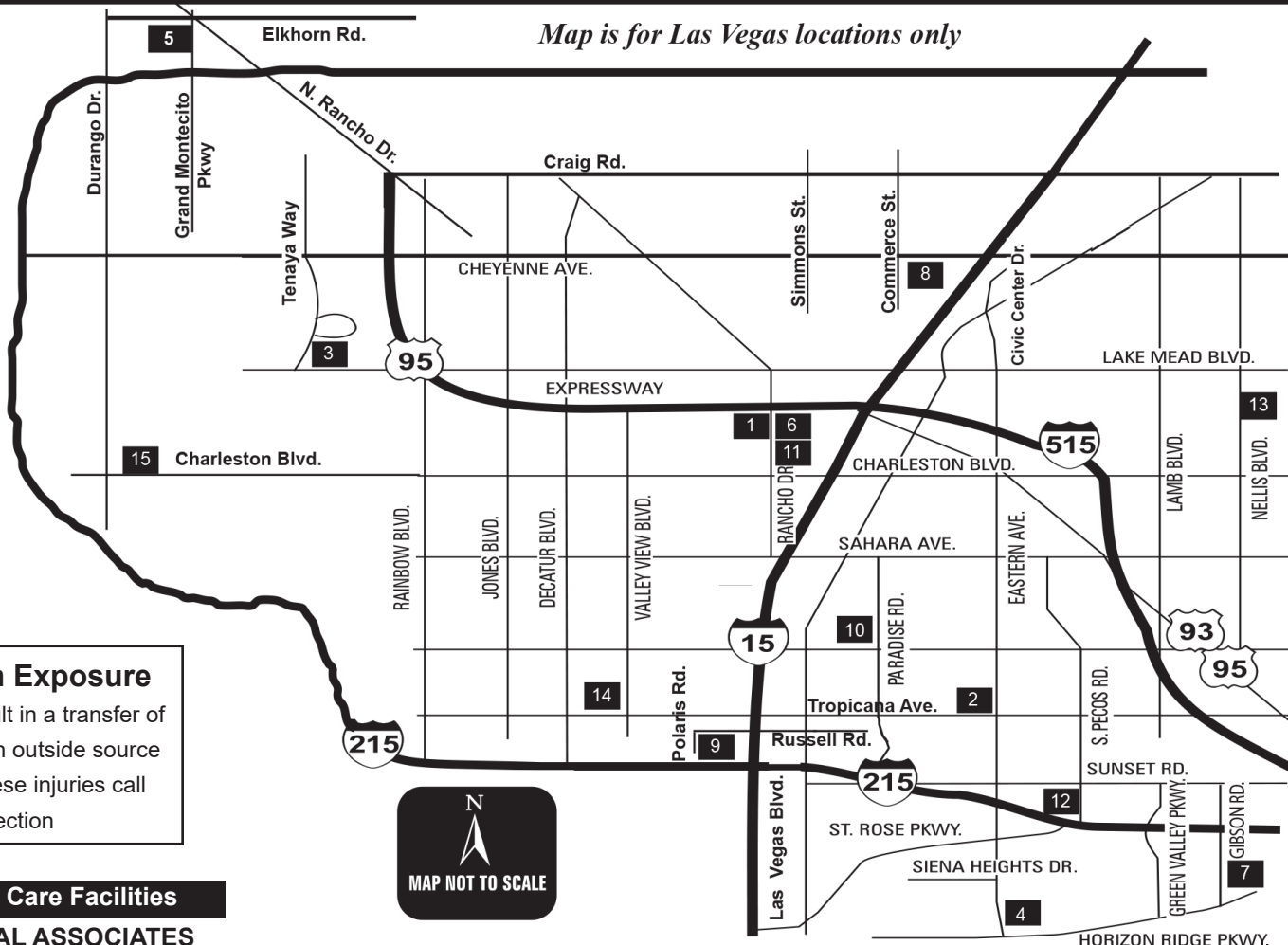
## A Registered Nurse Will Provide
