### **Mission Statement**

## **Principal's Highlights**

Desert Oasis High School, home of the Diamondbacks, opened in August of 2008. We proudly list these accomplishments and programs after eight years of growth.

- The Bowling team earned its first state championship.
- Numerous curricular initiatives tracked student achievement, increased graduation rates, and demonstrated gains on the School Performance Framework.
- The Desert Oasis Garden Project, which assisted students within our special programs, earned multiple awards and accolades.
- Community service projects included blood drives, elementary reading projects and numerous food/clothing drives for charities throughout Las Vegas.
- Student Council and DECA earned multiple awards on both the local and state level.
- Debate and Forensic teams earned multiple victories and qualified multiple students to nationals.
- All athletic programs, both men and women, continued to grow and improve, sending numerous teams and individuals to local and state competition.
- Band, orchestra, choir, theater, and color guard earned excellent to superior ratings in multiple music competitions and festivals.
- Unique ACT boot camps significantly increased scores on college readiness exams.

## **Goals and Objectives**

#### Goal 1

Increase the percentage of students graduating each year.

#### Objective(s):

Increase the percentage of students graduating from 75.84% to 78% by 2016 as measured by the NSPF.

#### Goal 2

Increase the number of students completing Advanced Placement (AP) and Career and Technical Education (CTE) courses each year.

#### Objective(s):

Increase the percent of students with completion of CTE courses from 54 in 2014 to 70 by 2016 as measured by the NSPF.

#### Goal3

Increase the percentage of school-based personnel trained in cultural competency.

#### Objective(s):

By April 2015, 95% of school-based administrators will participate in mandatory cultural competency training as measured by online module completion and Pathlore transcripts.

### **School Communication Efforts**

Desert Oasis High School employs various communication methods with all parents, students, and the community. The Infinite Campus system allows parents electronic access to their child's grades and attendance. The school's web page provides daily announcements, teacher email addresses, important event dates, tutoring and AP test prep dates, and the community newsletter. Open House in the fall provides parents with the opportunity to tour the school and meet our teachers. The auto-dialer sends messages to parents with important reminders and daily attendance of their children. Coaches, advisors, counselors, and administrators welcome incoming freshman and their parents at the annual Ninth Grade Night. Advanced Placement, College Financial Aide Night, and three athletic informational meetings are held to explain district requirements, school expectations, and answer any parent questions on college entrance or athletic eligibility. The principal meets monthly with the Parent Advisory Council to discuss educational topics and review suggestions to improve overall student achievement.
