The Attendance Zone Advisory Commission recognizes that its deliberative process benefits greatly from public input and perspective. Those wishing to address the Commission in person may sign up to speak once the agenda has been posted by calling the Demographics, Zoning, and GIS Department at (702) 799-6430, during regular business hours and at least 8 business hours prior to the scheduled start of the meeting.

Alternatively, speakers may sign up in person immediately prior to the beginning of the meeting. To minimize distractions, no additional speakers may sign up once the Commission Chair has introduced the agenda item. Customarily, speakers will be called in the order in which they signed up.

Members of the public are permitted to provide public comment on any agenda item requiring Commission action after staff presentations and discussion by the Commission, but before the Commission votes on the item. Speakers will be given 3 minutes to address the Commission and shall remain on topic.

A public comment period will be offered immediately prior to the adjournment of the meeting for members of the public who wish to speak on matters that are within the jurisdiction of the Commission not listed as an action item on the agenda. Each individual wishing to speak during this period will be given 3 minutes to address the Commission.

Written public comments may be submitted to azameetingcomments-user@nv.ccsd.net after the agenda has been posted and at least 8 business hours prior to the scheduled start of the meeting. Any written comments received after the deadline and prior to the meeting adjourning will be uploaded to BoardDocs within the appropriate item on the next business day.
