Discussion and possible action on approval to enter into Memoranda of Agreement between the Clark County School District and Communities in Schools, to provide Infinite Campus data with no impact to the general fund; Future Smiles, a Nevada nonprofit corporation, to provide Infinite Campus data with no impact to the general fund; Jobs for Nevada's Graduates, Inc., to provide Infinite Campus data with no impact to the general fund, for the sole purpose of assisting students obtain internet connectivity in order to provide distance education, effective August 9, 2020, for ninety days, unless the term is extended in writing and executed by all Parties; and Cox Communications Las Vegas, Inc., to provide affordable home internet services to eligible students, effective upon execution and until terminated by either Party; to be paid from Grant and/or General funds, and for the Superintendent of Schools, Clark County School District, and the President and Clerk, Clark County School District, Board of School Trustees, to sign the Memoranda of Agreement, is recommended. **(For Possible Action)** [Contact Person: Mike Casey] (Ref. 5.08)
