Prior to each agenda item being voted on, members of the public are allowed to speak on the item after the Commission's discussion and prior to their vote. Customarily, speakers will be called in the order in which they signed up.

No person may sign up for another individual. No person may yield his or her time to another person. A person wishing to speak on agenda items will be allowed 3 minutes to address the Commission. If the amount of public comment is large, the time may be adjusted to accommodate more speakers.

Written public comments may be submitted to alvarbi@nv.ccsd.net after the agenda has been posted and at least 3 hours prior to the scheduled start of the meeting. The Commission will no longer be summarizing written comments at the meeting, but the comments will be included on the record of the agenda.
