Trustee Guzmán asked if students who are going into the fifth grade could have the option of remaining at their current school.

Ms. Murphy said the Commission had discussions around siblings possibly having to attend different schools. She said there has not been the practice of grandfathering elementary school students, so that would be a new process for fourth-grade students. She stated costs for transportation was also discussed.

Superintendent Jara stated that grandfathering elementary students would include adding more transportation costs. He said at a time when the District has some challenges around transportation, implementing something that would be setting a precedent for the District would not be recommended at this time. He said approximately \$60,000.00 per bus would have to be added to the budget.
