APPROVED ZONING FOR THE 2017-2018 SCHOOL YEAR

Rick Baldwin stated all board item recommendations had been approved unanimously by the Board of School Trustees. He stated it has been a great year and a lot was accomplished. Rick reported several declaration of intent forms for the Smalley Elementary School and Walker Elementary School sibling option have been turn in to the Demographics, Zoning and GIS Department via US mail and walk ins.

Mike Malone stated he was pleased the Trustees did not make any changes to any of the board item recommendations.

THE 2017-2018 ZONING SEASON

Rick Baldwin stated the organizational meeting for next zoning season will be held at the end of August. Rick reviewed the AZAC Priorities list for the 2017-2018 zoning season. He stated five new elementary schools are proposed to open for the 2018-2019 school year. Rick stated when establishing attendance boundaries for these new schools AZAC may have to cross trustee district boundaries.

David Gomez asked what schools will be replaced.

Rachel Wren asked if the new proposed elementary school in District A would or could cross over to District G.
