Adoption of the Agenda

Trustee Bustamante Adams:

Next we're going to go on to item 2.02. This is the time and the place that was advertised for the public hearing on the tentative budget.

Trustee Brooks:

2.01.

Trustee Bustamante Adams:

2.01. Thank you. This is the time and place that was advertised for the public hearing on the tentative budget per Nevada revised statute 354.596. And the interested person shall be given an opportunity to be heard concerning the 2024-2025 tentative budget of the Clark County School District. I don't see anyone on the list to speak in public. Do we have any public comment cards? No, we do not. And somebody just joined, can you...

Trustee Cavazos:

This is Trustee Cavazos.

Trustee Bustamante Adams:

Thank you Trustee Cavazos. We are on item 2.01 during the public hearing on the tentative budget.

Trustee Cavazos:

Thank you.

Trustee Bustamante Adams:

But we have nobody on the list that called in advance and no public comment cards as is time. So therefore I will now close the public hearing and move on to item 2.02.

Trustee Brooks:

Call Jason up.

Trustee Bustamante Adams:

Oh, I got to call Jason up. Mr. Goudie, can you please come forward for your presentation and I'll turn it over to Interim Superintendent Larsen-Mitchell.

2.02 2024-2025 Final Budget.

Brenda Larsen-Mitchell:

Thank you Madam Vice president, members of the board. For the record, Brenda Larsen-Mitchell. This evening we have Mr. Goudie presenting the 2024/2025 final budget. So at this time with your permission, Vice President, I will turn it over to Mr. Goudie.

Jason Goudie:

Thank you. Jason Goudie for the record. The final budget... Where's the clicker? Hold on, pull that up. So here's a quick overview, same overview that we just saw during tentative budget.

Trustee Bustamante Adams:

Okay, thank you. Just for some clarification, I'm going to just go ahead and state for the record that we're going to go ahead and close 2.01 and we're going to move on to 2.02.

Jason Goudie:

Great, thank you [inaudible 00:06:49]. Thank you Vice President, members of the board, interim Superintendent Dr. Larsen-Mitchell. So the overview is the same that we presented just over 30 days ago related to the presentation. The timeline is saying... And this is the portion where we adopt the final budget. The next slide, the uncertainties under enrollment and risk of recession are still the same. We did not identify any changes there. Student enrollment is still anticipated and forecasted to be the same in an average ADE of 289, 350. Pupil-centered funding plan, same slide. Total pupil revenues, we are still anticipating the same 9497 that was approved by legislature and total of \$12,030 per student. Where the money comes from. This slide is essentially the same with some minor changes. State education funding \$3253.6 billion, which is just about 94%. And the other 226, and those are essentially the same numbers. The only thing that has changed is up in the top.

We previously had an estimated fund balance of 510.4 and now it is down slightly to 497.6, which I will highlight later. And then also that includes an unassigned fund balance of 151.6, which is slightly down from the 156.6 that was presented during tentative budget. The general operating revenues have not changed as noted from the tentative budget. And so there's, reflected there at the bottom, no change since tentative. Therefore, the state assumptions projections and assumptions slide did not change. Still we are having an increase about \$102 million, which is based off an increase in per pupil funding with a slight enrollment loss. Where the money is spent. This is again very similar. There was an increase in school-based dollars going up to \$606.2 million. That is basically based off of the increase in special education funding that I'll talk about a little bit later as well.

Jason Goudie:

Typically and consistent with tentative budget, I will walk through the technology and the professional services spend. So in technology we have just around \$61.8 million. I'll go through the large components. There's \$15 million in for internal audit software licenses, hardware, desktops, laptop upgrades. There's \$8.4 million for our human capital management system, Arisant, which is a consultant to help with that, CherryRoad which is also helping and [inaudible 00:09:54] Corporation which also helps. We have \$5.5 million in network servicing, computer assisted instruction. We have \$5.2 million in user support services. This is Apple One, Chromebook, case warranties, software licenses. We have \$4.8 million in central information services. This is Arisant again, SAP, which is our financial software. IBM endpoint technologies. We have \$4.2 million in innovation and products, this is Dell Technologies, unified shared servers, etc. 4.1 in assessment map growth. We have \$3 million in tech services, which is software maintenance and renewals. And then we have \$2.8 million for emergency management related to motor [inaudible 00:10:46] radios, lighting, vehicle, emergency packages, etc. And then we have \$2.8 million of student information systems, Infinite Campus, Apple One contractors and some other [inaudible 00:10:58].

Trustee Bustamante Adams:

Mr. Goudie, can I pause you for a second? Trustees on the phone if you could mute yourself, we can hear the conversations. Thank you. Please continue Mr. Goudie.

Jason Goudie:

Thank you. And so those are the major components of our IT spend. Professional services, \$9.7 million for speech pathology, speech therapists. 8.7 for Accelerations Academy. This is dropout recovery services. And again, I like to point out that that is essentially cost neutral to us. We only have a cost if we recover funding through the pupil-centered funding plan. We have occupational physical therapy of 7.4 million. We have \$7 million of contracted nurses. \$5.5 million of social workers and other mental health services. \$4.7 million related to athletic events, referees, physical therapy, etc. 3.4 million related to office of general counsel for legal services. 3.3 million in Hope Squared. 2.5 million in general maintenance contractors for some preventive maintenance. \$1.9 million for online vendor course management. This is Apex Learning and Instructure. \$1.7 million for transportation, admin, student transportation services. 1.7 for general accounting, which includes banking fees, audit fees, Brink's, Bank of America, financial services, etc. And the last piece is 1.6 million. This is Lockton Health, which is our benefit advisors, our [inaudible 00:12:25] whole health wellness centers, which are provided to our employees that are under our medical benefit plans, free of charge. And then some other miscellaneous professional services.

So this is where the money spent. This did change a bit from the tentative budget as we did identify a couple of errors in the last presentation in the office of the superintendent, it was inadvertently reported as 240 FTEs and it should have been 14. We have corrected that. And \$20.2 million of funding, which should be the 3.5. So we corrected that. All of those personnel and dollars should have been down in strategic budgets and we have realigned those. Additionally, the operational services unit has increased from \$150.2 million to 162.7. This is primarily related to IT components around one-to-one services and product. Additionally, teaching and learning did go up from 195.8 to 200.6. And again, that is due to some of the additional special education personnel that are located in the general fund. The business and finance unit also... And again did put that number... That went down by just around \$50 million. And that is what we had talked about in the prior meeting.

And tentative in our assigned balance, we had some budget requests that were coming through related to some IT costs for the protection of the cyber security and some other components. So that was expected.

Jason Goudie:

And so that is why that number is lower. And then strategic budgets are very close except for the adjustment that we made to correctly prior error. Special education, again very, very similar with the only major change coming in the licensed positions. And so again, that was an increase related to a number of additional licensed personnel required under our special education services.

So when we look at the changes from the tentative budget, our final budget has a beginning fund balance of 497.6. That is down approximately \$20 million. And that decrease is primarily due to our forecasted lower school carryover forecast in this budget from the prior budget. We also had an increase in salaries and benefits primarily around special education, and some of the minor changes we had for personnel and IT. And then additionally, services and supplies, those slight increases from the tentative budget are primarily related to the IT increases related to one-to-one devices for services as well as products. The unassigned ending fund balance is still projected to be at 4.5%, which is the same as tentative budget. We have no updates on employee contract status. And that concludes my presentation. I'll open it up to any questions.

Trustee Bustamante Adams:

Thank you Mr. Goudie. Are there any questions from the trustees here on the dais? Seeing none, then I will go to the phone. Any questions Trustee Garcia Morales?

Trustee Garcia Morales:

Not at this time. Thank you

Trustee Bustamante Adams:

Trustee Cavazos, any questions? Trustee Johnson?

Trustee Johnson:

None for me. Thank you.

Trustee Bustamante Adams:

Trustee Williams?

Trustee Williams:

None for me. Thank you, Madam Vice President.

This is Trustee Cavazos. I think I was on mute, Vice President Bustamante Adams.

Trustee Bustamante Adams:

Yes. Trustee Cavazos, any questions for you?

Trustee Cavazos:

No, my questions were answered previously. Thank you.

Trustee Bustamante Adams:

Thank you. I do have a question, Mr. Goudie. So on page eight, so what I'm taking away is that you guys did an excellent job in the projection with the final, which I want to congratulate you on. My question then is on the slight reduction in attendance, I don't know if it was that page, but it says something in parentheses, unweighted, that's on page 10. So it says a projected enrollment loss of 3,066, and then it says full unweighted. What does that mean?

Jason Goudie:

So there are... Jason Goudie for the records. So there's just a couple of calculations that the state requires us to include in our state forms and one is the weighted 3,066, which is the portion that includes how we actually get funded and then we also just have to disclose the full unweighted calculation.

Trustee Bustamante Adams:

Oh, I see. Got it. Okay, then seeing no questions, I want to be able to thank the taxpayers and the legislature for the increase in the funds for our teachers and other support staff. With that then I am going to go ahead and entertain a motion for acceptance of the final budget.

Trustee Esparza-Stoffregan:

Vice President Bustamante Adams, this is Trustee Esparza Stoffregan. Can you hear me?

Trustee Bustamante Adams:

Yes, I can. Thank you. I didn't know you were on the line. Did you have any questions?

Trustee Esparza-Stoffregan:

So at this time I do not. It's just because we are at a graduation and I just want it to be noted on the record that I am in attendance. The phone line here is dropping at Thomas & Mack. Thank you.

Thank you so much. I appreciate that.
