ADOPTION OF AGENDA

REPORTS

Steve Burda stated that there were no new Reports to present.

PRESENTATION OF THE 2022-2023 ENROLLMENT REPORT

Steve Burda stated that current and previously provided 2022-2023 Enrollment Reports can be found on the Demographics, Zoning, and GIS webpage.

EVALUATE SCENARIO(S) FOR FOCUS AREA C1 FOR ELEMENTARY, MIDDLE, AND HIGH SCHOOLS
Steve Burda presented Focus Area C1, Scenarios 2 and 3; Arbor View, Centennial, and Indian Springs High Schools. Primary reason for the rezoning is due to new residential development under construction north of Kyle Canyon Road and west of US-95. This places the new development in Indian Springs Elementary, Middle, and High Schools, approximately 25 miles north. The consideration would utilize available capacity at James H. Bilbray and William and Mary Scherkenbach Elementary Schools and Edmundo "Eddie" Escobedo Sr. Middle School.

Steve Burda presented Scenario 2. He stated that Centennial High School is now included in this focus area. The areas being recommended for evaluation and assignment from Indian Springs High School to Centennial High School is from the Lower Kyle Canyon Advance Limit, east to Moccasin Road, to US-95, south to Kyle Canyon Road, west to the Corporate Limit, south of the Lower Kyle Canyon Advance Limit, west to Lone Mountain Advance Limit, south to Lower Kyle Canyon Advance Limit, north along the Precinct Boundary, continuing to Moffatt Boulevard Zip Code Boundary. He stated that the areas being recommended for Arbor View High School begin at the Lower Kyle Canyon Road Advance Limit, east to the Corporate Limit, south to the extension of both sides of Tracy Stevens Avenue, east to the Precinct Boundary, south to the Parcel Line, in alignment with Elkhorn Road, and west to the Lone Mountain Advance Limit. Mr. Burda stated that this scenario is recommended to go from Arbor View High School to Centennial High School, moving zero existing high school students, with potential for 18 students from future developments in that area.

Steve Burda presented Scenario 3. He stated that the same area is recommended to change from Indian Springs High School to Centennial High School. The area proposed to move from Arbor View High School to Centennial High School begins at the Lower Kyle Canyon Advance Limit, east to the Corporate Limit, south to the extension of Farm Road, east to Hualapai Way, south to Elkhorn Road, then west on Elkhorn Road, west along the Promenade Trail to the parcel line to Lone Mountain Advance Limit. This would move 202 existing students and 21 future students from development.

Lydia Ruiz asked how many students would be impacted by Scenario 2.

Steve Burda stated that zero students would be impacted by Scenario 2.

Lydia Ruiz asked Transportation how many students would be affected by Scenario 3.

Brandon Yacub stated that 150 students would be affected by Scenario 3.

Lydia Ruiz stated that any students in athletics can continue and are protected by NRS 385B.060.

Nicholas Fedei stated that the maps were closely looked at to offset the overages going to Arbor View High School, so Centennial High School was brought in to alleviate some of the over capacity.

Anna Binder asked for clarification on the numbers below the school name on References 2.04(A) and (B).

Steve Burda stated the number is the geographic total number of students that reside in that area. Anna Binder asked for representation from the NIAA for proper authority on the athletic code.

Matthew Tramp stated that staff was given proper interpretation of the law.

Anna Binder is requesting the proper representation for the public for the disclaimer at a public input meeting.

PUBLIC COMMENT

John Mismas, parent, Arbor View High School, is concerned about the overcrowding at the school. He likes the scenarios but states that a new high school will be the best solution.

Stephan Slaughter, parent, Arbor View High School, is concerned about the overcrowding at the school. He would like to see a new high school in the near future.

Brittany Chamberlain, parent, Arbor View High School, agrees with Scenario 3. She is concerned about the safety and education of students.

Alex McGurk, parent, Arbor View High School, states she is in favor of Scenario 3. She suggested that Shadow Ridge and Legacy High Schools be added to help alleviate the overcrowding at Arbor View High School.

Lydia Ruiz asked when the new high school would be built.

Steve Burda stated the new comprehensive high school is tentatively scheduled for 2028.

Anna Binder asked if there are any plans to open a magnet school in the area.

Steve Burda stated that a comprehensive technical academy high school is scheduled to open for the 2023-2024 school year.

Anna Binder stated concern that Scenario 1 for the elementary and middle schools were not included for this meeting.

David Hall stated that the maps would not preclude moving forward and the schools are properly noted in the Agenda.
