APPROVED ZONING FOR THE 2023-2024 SCHOOL YEAR

Tracy Murphy stated that all six recommendations were approved at the Joint Meeting of the Board of School Trustees and AZAC on February 28, 2023; of the six recommendations, four were from AZAC and two were from staff. Ms. Murphy provided further details on staff recommendations.

Anna Binder appreciated the information provided on staff recommendations.

REVIEW OF THE 2023-2024 ZONING SEASON PRIORITIES

Tracy Murphy stated there are no zoning priorities at this time; there are no new schools next school year that will need to be rezoned and no magnet school attendance boundaries to be reviewed.

Tracy Murphy stated that according to the bylaws, the deadline for reappointments to AZAC is June 15, 2023, and new appointments are September 15, 2023. She said that Regulation 7111 states that Demographics and Zoning will provide enrollments and capacities to AZAC and to region leadership to determine the focus areas for the next school year.

Nicholas Fedei stated that he has a recommendation and will address it to his Trustee.

Matthew Tramp asked when the new Northeast Career and Technical Academy will open.

Tracy Murphy stated that it will open in August 2023.

Matthew Tramp asked which areas the Northeast Career and Technical Academy will attract.

Tracy Murphy stated that when the Northeast Career and Technical Academy opens, it is anticipated to alleviate enrollment in the proximity of the northeast area and at other Career and Technical Academies.
